MINUTES ADMINISTRATION & FINANCE COMMITTEE September 19, 2017

1. Roll Call:

A regular meeting of the Hoffman Estates Park District Administration & Finance Committee was held on September 19, 2017 at 7:20 p.m. at the Triphahn Center in Hoffman Estates, IL.

2. Approval of Agenda:

Comm Rep Utas made a motion, seconded by Comm Rep Chhatwani to approve the agenda as presented. The motion carried by voice vote.

3. Approval of the Minutes:

Comm Rep Musial made a motion, seconded by Comm Rep Chhatwani to approve the minutes of the September 19, 2017 meeting as presented. The motion carried by voice vote.

4. Comments from the Audience:

5. Old Business:

None

6. New Business:

A. Amita Sponsorship Agreement/M17-107:

Deputy Director Talsma reviewed the item noting that Adv & Spons Manager Massani had negotiated the contract to \$67,240 up from \$50,000.

Comm Rep Musial asked how they reached that amount and Deputy Director Talsma noted that part of it was assigning value to items. Comm Rep Musial asked it the participation of events included the Foundation and Deputy Director Talsma noted that it did not. Comm Rep Musial asked about the new merging and if it would impact the contract and Deputy Director Talsma noted that he did not think it would.

Commissioner McGinn asked if this would be considered a charitable contribution for Amita and Deputy Director Talsma noted that as a health care provided there was an unspoken requirement that they give back to the community.

Commissioner R. Evans asked about the Kioske at the hospital and it was noted to still be a part of the contract and that C&M updated the information for the Kioske.

Commissioner Bickham asked about signage and it was noted that there would be the marquee signs and other banners. Commissioner K. Evans asked if they could be advertised on the non-commercial signs and Deputy Director Talsma explained that they could.

Chairman Kilbridge asked if their headquarters were in DuPage given the court they were assigned to and President Kaplan said it was most likely.

Chairman Kilbridge asked about the "I am healthy" summer camps and Deputy Director Talsma explained that it was a conceptual idea at this time.

Commissioner Bickham made a motion, seconded by Commissioner Utas to recommend the board approve the annual sponsorship agreement for Amita Health Care for July 17, 2017 to July 16, 2018 in the amount of \$67,240.00. The motion carried by voice vote.

B. Electricity Fixed Rate Contract/M17-108:

Deputy Director Talsma reviewed the item noting that the district had locked in a \$.06354 rate for a 3-year period from December 2017 to December 2020. He explained that the natural gas contract would come due next year.

Commissioner K. Evans asked about the number of accounts and Deputy Director Talsma noted that 30 of the 34 accounts were on this contract and the few remaining contracts were old contracts for lights only in parks from dusk to dawn.

Comm Rep Utas made a motion, seconded by Comm Rep Chhatwani to recommend the board approve entering into a fixed rate contract for electricity for a period of 3-years at \$.06354 with Direct Energy. Motion carried by voice vote.

C. <u>A&F Report/M17-106:</u>

Deputy Director Talsma reviewed the item noting that the district had been receiving additional personal property replacement taxes in the amounts of 2013/\$57,000, 2014/\$59,000, 2015/\$62,000 but we were looking to see a 24% loss because the State of Illinois was holding back payments and that could come out to about \$12,000.

Commissioner K. Evans asked about the work with the Village on alternate energy sources. Deputy Director Talsma explained that staff had been to two meetings and talked about potential future use of natural gas fleet vehicles. He noted that presently the only public station was near O'Hare airport and that it could take up to 12 hours to fill a tank; something that would not work for fire trucks or police cars.

Chairman Kilbridge asked about the budget meeting timelines. Staff will confirm the dates.

Comm Rep Utas made a motion, seconded by Comm Rep Chhatwani to send the A&F Report M17-106 to the board. The motion carried by voice vote.

D. Open and Paid Invoice Register:

Chairman Kilbridge asked about the monthly rent for refrigerators at BPC and Deputy Director Talsma explained that it was more cost effective to rent the large fridges than to purchase and pay for maintenance.

Commissioner Bickham made a motion, seconded by Comm Rep Chhatwani to recommend the board approve the Open and Paid Invoice Register in the amount of \$964,511.96. The motion carried by voice vote.

E. Revenue & Expense Report:

Deputy Director Talsma noted that the district was doing well. He reminded the committee that the district had spent some of the fund balances on capital projects. Comm Rep Utas made a motion, seconded by Comm Rep Chhatwani to recommend the board approve the Revenue & Expense Report as presented. The motion carried by voice vote.

7. <u>Committee Member Comments:</u>

Comm Rep Utas noted that Hockey was here. He asked staff about putting the girls' teams into the small locker room also being used as storage and if they could not find a more adequate locker room. Executive Director Bostrom noted that the initial idea was for a single girl or two on a team to have a locker room area for changing but that with full teams of girls playing hockey, they should have one of the regular locker rooms. Director Kies noted he would talk with staff.

Commissioner Bickham reminded everyone of the Wolves Exhibition Game September 30, 2017 and of the Wild Flower Seed event on the north side.

Comm Rep Musial asked if the Comm Reps could be kept updated with regard to the Executive Director Search. Staff will forward information.

Comm Rep Chhatwani noted that she had a very successful party at Seascape.

Chairman Kilbridge noted that the Foundation had a very successful Uncorked and Untapped event.

8. Adjournment:

Comm Rep Utas made a motion, seconded by Comm Rep Chhatwani to adjourn the meeting at 8:00 p.m. The motion carried by voice vote.

Re: Naming and Renaming of Park Sites, Policy 5.05

Background

Mr. David Kumpula submitted a letter dated August 17, 2017, attached, requesting to rename Sycamore Park in honor of the late Mayor Michael O'Malley. In addition, Mr. Kumpula submitted a letter dated August 22, 2017, attached, requesting the installation of a plaque on the concession stand at Sycamore Park recognizing the 1987 HEAA Board and coaches. Both requests are subject to Park District Board Policy 5.05 Naming and Renaming of Park Sites, which is outlined below:

5.05 NAMING AND RENAMING OF PARK SITES

The Board shall select names for new parks, buildings, facilities, athletic fields, or, when appropriate, to change the name(s) of existing parks, buildings, facilities, or athletic fields of the district that have not been dedicated. The Board may consider the following elements in determining the naming or renaming of parks, buildings, etc. (for purposes of this section only, "parks" shall means parks, buildings, facilities, athletic fields, or other "namable" property of the District):

- A. Parks may be named after streets, geographical locations, historical figures, events, concepts or as otherwise determined by the Board.
- B. Parks may be named for individuals or groups that have donated land or facilities to the District or made a significant financial contribution toward the development of parks.
- C. Parks may be named for individuals or groups that have made exceptional contributions to the community. Names of individuals, including, but not limited to, District Commissioners or other public officials, may not be given to a park, building, facility or athletic field unless the individual is deceased or if the Board determines that there are substantiated extenuating circumstances whereby the naming of the park, building, facility or athletic field prior while the individual is alive serves the best interests of the district.
 - 1) The Board at public meeting should first

- announce the proposed name of the park, building, facility or athletic fields (requires a 5/7 vote).
- 2) A park site should only be confirmed and the name made official after a waiting period of at least sixty (60) days before the confirmation vote. However, when the substantiated extenuating circumstances clause noted in C above is invoked, the 60 day official waiting period may be waived at the discretion of the Board before the confirmation vote.
- A 5/7 vote by the Board is required to name a park, building, facility, or athletic field or to change the name of an undedicated park, building, facility or athletic field of the District.

The Park District has four park sites that are currently named after individuals consistent with Policy 5.05:

In 1999 Kelly Park was renamed Cannon Crossing Park in recognition of **Bill Cannon**. Bill was a very active volunteer in the Hoffman Estates community and longtime Park District volunteer for various youth athletic programs.

In December of 2010, the Community Center and Ice Arena was renamed the Scott R. Triphahn Community Center and Ice Arena in recognition of **Scott Triphahn**. Scott was a highly influential Park District Commissioner for 12 years, a passionate volunteer youth athletic coach, founding President of Friends of H.E. Parks Foundation and steadfast pillar of Hoffman Estates.

In January 2015, Highpoint Park was officially renamed Joseph L. Fabbrini Park. **Joseph L. Fabbrini** was an individual who made exceptional contributions to the community and was one of several early community leaders who had a vision of creating a Park District for Hoffman Estates. Joe served as one of the first Park District's Commissioners and the first Director through 1967.

In January 2016, Victoria Park Playground was renamed Peter M. Smith Playground. **Peter Smith** was a true champion and advocate for promoting equal access for all individuals with disabilities. Peter Smith was credited with being responsible for creating the Village of Hoffman Estates model accessibility ordinance. This ordinance was the first of its kind in Illinois and required that all public buildings be architecturally accessible to the handicapped. Peter served as Park Board Commissioner of the Hoffman Estates Park District, served on the Park District's Special Recreation Committee and was instrumental in spearheading the district's dropin center for physically handicapped adults. Peter served as an active member of the Hoffman Estates Commission on Seniors and Disabled.

Implications

Mr. Kumpula's letter dated 8/17 requesting to rename Sycamore Park in honor of the late Mayor Michael O'Malley, reiterates the generosity of the late Mayor who on numerous occasions during the summer of 1985/1986 treated young baseball players to

pizza and ice cream following their games. Mr. Kumpula's request is further supported by Carol Salley who submitted the attached email received on 9/24. Ms. Salley in her email also speaks to the Mayor's generosity in buying post-game treats for young baseball and football players. In addition, Ms. Salley wrote about how HEAA was unable to secure the Village's required permit to operate the concession stand prior to their first game in 1988. Mayor O'Malley was able to secure the permit in time for the first game of the season.

Both letters of support to rename Sycamore Park after the late Mayor O'Malley deal with the late Mayor's compassion for young athletes who participated in both the Hoffman Estates Community Baseball Association (HECBA) and HEAA programs which are independent of the Hoffman Estates Park District. Staff inquired with former Park District Commissioners who served on the Park Board at the time Mayor O'Malley served as the Mayor of Hoffman Estates (1989-2000). Three former Commissioners responded all agreeing that Mayor O'Malley was very gracious, friendly and well liked within the community. However, two of the three Commissioners expressed that during Mayor O'Malley's tenure as Mayor of the Village of Hoffman Estates, Park District/ Village relations were often times strained and no examples were provided as to how the Village, during the Mayor's tenure, made exceptional contributions to the Park District. In addition, it was pointed out that on November 17, 2001 the Village named its Fire Station 22/Headquarters in honor of the late Mayor Michael O'Malley.

Mr. Kumpula's letter dated 8/22/2017 requested that the Park District install a plaque on the concession stand at Sycamore Park to recognize the 1987 HEAA Board and coaches. As this request specifically involves HEAA, which is a separate 501(c)3 organization totally autonomous from the Park District, Mr. Kumpula's letter was forwarded to Mark Mueller, President of HEAA.

It was communicated to Mark Mueller that if the HEAA Board agreed with the request to install the plaque, that the Park Board would then evaluate the request as submitted by Mr. Kumpula and endorsed by HEAA. Mark Mueller, however, communicated back to the Park District that the HEAA Board was not interested in installing a plaque to recognize the 1987 HEAA Board and coaches. Therefore, the Park District should not act on this request without the support of the HEAA Board.

Recommendation

It is well documented that the late Mayor Michael O'Malley was very generous to many of the young players who participated in both the HEAA and HECBA programs and his contributions to the community have been considered to be exceptional. However, his contributions to the community as Mayor of Hoffman Estates were previously recognized with Fire Station 22 named in his honor. It appears that during his tenure with the Village of Hoffman Estates, no significate contributions were made to the Park District, therefore, it is recommended that Sycamore Park not be renamed after the late Mayor Michael O'Malley per Mr. Kumpula's request. Furthermore, as the HEAA Board does not support the request to install a plaque on the concession stand at Sycamore Park to recognize the 1986/87 HEAA Board and coaches, that no further action from the Park District be taken on this request.

To: President Bostrom and the Hoffman Estates Park Board Members

This is a request to rename Sycamore Park (the athletic field at Lincoln Prairie School on Hillcrest Road) in honor of the late Mayor Michael O'Malley. The property comprises a football field and two Little League baseball fields. This seems fitting because of all the support he provided for Hoffman Estates youth sports.

I have always regretted not relaying two relevant stories to the Daily Herald when they published an entire section of tributes to Mike following his death in which people had an opportunity to tell of the ways that Mike touched their lives.

Here are my stories. These happened around the 1985 and 1986 baseball seasons. Although I had no children in the HECBA program, I spent the summers coaching because I enjoy the game. I supplied gum and occasionally treated the boys to ice cream after a game.

On the first occasion, Mike stopped by a game and, out of the blue, told me to take the kids to Sarpino's Pizza and let the owner know that Mike sent us. He paid for all the pizza and pop.

The second occasion was in 1986. We had a team that went to the Elgin Invitational Tournament. (I don't know if they still have this one, but back then it was a big deal.) Not one representative of HECBA came to the game, but Mike did. It was a night game, and he attended after he had done a full day of work for the Village.

As I said in my August 8th article in the Daily Herald Fence Post, I know Mike unselfishly supported Hoffman Estates sports programs, and it would be fitting that this field/park reflect this. The oversight has gone on for too long. My final hope is that the Board approve the renaming of this field in memory of Mike O'Malley.

Dear Mr. Bostrom,

I would be supportive of Mr. Kumpula's request to rename one of the parks in Hoffman Estates in honor of the late Mayor O'Malley. From my perspective as a parent, former board member of HEAA (Hoffman Estates Athletic Association), and a resident of the village, I saw firsthand Mayor O'Malley's commitment and "hands on" interaction with the youth of this community. A few of the interactions I personally witnessed were:

- When the old Community Pool was closed down, my nine year old daughter, Angela was very upset by this, as she spent a lot of time there during the summer months. She wrote a letter to the editor of the Daily Herald, expressing her concern about Hoffman Estates not having a pool in the village. The letter was published in the local paper. Mayor O'Malley read the article, and called Angela; invited her to his office, and listened to her concerns, agreeing with her that the village should have a pool. She returned home just beaming, and said how nice the Mayor had been to her.
- My husband, Howard Salley, was the head coach for HECBA baseball for our sons, and every year they were treated to pizza night by Mayor O'Malley.
- Another instance I can relate is regarding the restart-up of the HEAA organization. My husband, Howard Salley, became the president of HEAA in 1988, and I became a board member. The group that took over the administration of HEAA had a mighty task, the organization had previously been poorly managed; it needed new equipment, regular playing schedules and healthy financials. One item that I was involved with was setting up concessions for the home games. Hoffman Estates resident and HEAA parent, Cindy Stevens, who was the head of our Concessions committee, called me prior to our first game, to advise that she had a problem; as she was told HEAA could not obtain a permit to vend concessions at Sycamore Park, as there was a village restriction on vending at the park due to a previous vendor. I called Mayor O'Malley, and said, "Mike, I am looking for a friend for the youth football organization in Hoffman Estates." Mayor O

'Malley responded, "When have I never been a friend to youth sports in Hoffman?" I said, "Never, that is why I am calling you!". I then explained the situation, he responded by conferencing the phone to a Village official, explained to them the problem, and said, "Can we take care of this immediately? Their first game is tomorrow!" It was done, and Mayor O'Malley was the first one in line at the game to buy a hotdog, and soda! After that he attended games regularly, and a couple of his sons also joined the teams. HEAA has gone on to become a great organization, winning National Championships, and it always has a team, football and cheerleading, representing Hoffman Estates at the National Championships. It has put our village on the map for our athletic and scholarly achievements. Many of the youth that were members of the teams during those start-up years have now come back to the organization and are the coaches, parents and volunteers in HEAA today. This would not have been possible without the support of great, late, Mayor and his Village Board, and for that alone he should be remembered!

I thank you for this opportunity to go down memory lane, and to share these great stories, and to give the appropriate credit where it is due.

SUBJECT: Roof Top Unit Additions to 2017 Capital Budget

DATE: October 18, 2017

Background

The 2017 Capital Budget includes \$48,000 to replace two Roof Top Units (RTU) at Willow Recreation Center. The two RTU's that are scheduled to be replaced are RTU #1 and RTU #6. After evaluations of the district's RTU's, staff is recommending that RTU #3 at Prairie Stone is also in need of immediate replacement. These unit are all separate single units from three different manufactures with prices obtained through quotes from the manufactures. If these units were to be bid out it could require changing mechanical setup and duct work.

Implications

Cost implication of each unit is broken down below. The important cost to consider is the cost of the crane. The major cost of the crane is not lifting the units into place, it's the cost of getting the crane to our site and setup.

- RTU #6 Allied provided by G.W. Berkheimer Co., INC. \$8,600+\$1,650 (install)
- RTU #1 is a Trane unit \$12,805
- RTU #3 @ PSS&WC is a Carrier Unit \$22,301
- Crane Cost \$6,460

We can have all three units lifted to their respective roofs with the crane for the cost of \$6,460. If we are to only install the two budgeted RTU's at Willow we would be under the 2017 Capital budgeted amount, but that would leave us with the need to install RTU #3 at PSS&WC next year (2018) and be charged an additional \$5,420. By combining the units at one time we would be saving that \$5,420 charge. If we were to have all three units installed at one time our cost would be \$51,816. If the district were to do these units separately our cost over 2017 and 2018 would total \$57,236 to have all the units installed.

Recommendations

That the A&F Committee recommends to the full board to approve an additional amount of \$3,816 for the 2017 RTU Capital Account Budget to allow for the purchase and installation of the aforementioned RTU's at a cost of \$51,816.

Re: Comcast Network Infrastructure Renewal & Upgrade

Background

In 2015, the District signed a three year contract with Comcast to upgrade our network infrastructure. The upgrade laid down a foundation for our Shoretel phone system as well as to provide better and faster speeds for the ever increasing needs of our internet based business applications. This contract with Comcast is set to expire March 2018. Staff has been planning to upgrade the network infrastructure to include a foundation for a disaster recovery & redundancy plan, to provide faster internet speed for our GIS application at Parks, and to upgrade current coax lines to more reliable & scalable fiber based lines.

Our current network topology is based on what Comcast calls Ethernet Virtual Private Line (EVPL). This is essentially a hub & spoke network design in which Triphahn is the central location (hub) of the network. All remote facilities: Bridges (BPC), Prairie Stone Sports & Wellness (PSSWC), Willow (WRC), & Parks) utilize a coax line to communicate back & forth with Triphahn (TC). TC is currently the only facility on fiber with a dedicated internet line of 100Mbps which all facilities share. The current local network speeds for each facility are as follows:

- BPC 10Mbps
- PSSWC 10Mbps
- WRC 4Mbps
- Parks 4Mbps
- TC − 28Mbps

As the hub, TC's local network speed is 28Mbps, which is the sum of all the remote facilities' speeds. Internet & network connectivity over fiber has become the gold standard for fast, high-quality data transmission for businesses. Considered "futureproof", this technology relies on clusters of transparent glass fibers, each about the same diameter as a human hair. Electrical signals carrying data are converted to light which results in much faster speeds compared to coax. Although fiber lines are hair-thin, they have the capacity for greater bandwidth & have higher reliability than traditional coax. We potentially could go up to 1000Mbps (1GB) if our business needs demand it.

The proposed network topology, which can support disaster recovery, is what Comcast calls Ethernet Network Services (ENS). This is referred to as a mesh network design in which all facilities can access one another without having to go back to a central hub. Along with the change in network topology, a second dedicated internet line at Parks will be installed and all coax facilities (BPC, WRC, & Parks) with the exception of PSSWC will be upgraded to faster fiber based lines. PSSWC current construction cost because of their geographical location will not yet support the installation costs to provide this facility with fiber.

Implications

We are highly invested in Comcast's enterprise solutions and have been extremely satisfied with not only the overall performance but the standard of care and minimal downtime the District has experienced. The original migration provided our facilities with stable and faster connectivity. The proposed upgrade includes all facilities changing to the ENS topology as well as:

- BPC would be upgraded to fiber and their local network speed would increase from 10Mbps to 20Mbps.
- PSSWC would stay on coax and their local network speed would increase from 10Mbps to 20Mbps.
- WRC would be upgraded to fiber and their local network speed would increase from 4Mbps to 10Mbps.
- Parks will receive the most drastic change as they will act as our disaster & recovery location. Parks will be upgraded to fiber and their local network speed would increase from 4Mbps to 50Mbps. They will also have a 50Mbps dedicated internet line second only to Triphahn in speed. The dedicated internet line will help load balance the District's internet traffic as well as make our GIS application run more efficiently. As part of the disaster recovery and redundancy plan we will plan to install hardware (i.e. server, firewall, & switch) to mimic Triphahn in the event of a disaster. If a disaster were to occur at Triphahn, all traffic would be redirected to Parks and we would have business continuity within a few hours instead of weeks depending on the severity of the disaster.
- TC's local network speed would increase from 28Mbps to 100Mbps. This is to ensure that Triphahn will be capable of sustaining the sum of all the remote facilities speeds. Triphahn's 100Mbps dedicated internet line will continue to be shared by all facilities.

Below is a table that summarizes the changes as well as the associated costs.

Construction costs to bring Comcast's fiber to the aforementioned facilities are estimated at \$50,000. This cost would be waived if we enter into a new three year agreement with Comcast for the other services. There is approximately a 120 day installation period due to the construction for the new Fiber lines.

The total cost of Comcast's proposal is \$6,667.50 per month (plus surcharges & taxes) for a three year contract. The District is currently paying \$4,389.50 per month. Comcast's knowledgeable account team, excellent reputation, & impressive Service Level Agreements (SLA), will provide the District with stable & scalable bandwidth as our needs change and increase in the future. The contracting of data services is not required to be bid and the District may enter into a three year contract for such services.

Recommendation

That the A&F Committee recommends to the full board to enter into a three year contract with Comcast to provide the District the outlined network infrastructure renewal & upgrade for a base monthly cost of \$6,667.50 plus taxes and fees.

Background

The Hoffman Estates Park District has been utilizing Sikich, LLC for our auditing service provider for the District. Staff has been very satisfied with Sikich and they have provided a very professional auditing experience and excellent final Comprehensive Annual Financial Report (CAFR) during the last five years. Auditing services are evaluated through the RFP process typically every five years due to the nature of the auditing agreement to be for three years with a contingency to extend for up to two years (based on District satisfaction). The agreement with Sikich, LLC concluded with the issuance of the 2016 audit (CAFR).

Implications

Based on a recent survey asking park districts who they utilized for auditors, staff selected the three most qualified firms (based on current usage and personal past experience). Survey results also indicated other districts using the services of Seldon Fox and Knutte & Associates. The District has used both of these firms in previous years and based on experience, does not feel they provide the level of auditing service the District has become accustomed to with Sikich, LLC. Staff also posted the RFP on our web site.

Staff has requested RFP's from McGladery LLP, Lauterbach & Amen, and Sikich, LLC. Below are the RFP's received, McGladrey, LLP did not submit an RFP and one was submitted based on the notice on our web site Erichsen, Kallsen & Assoc.).

Background

Each year the District issues a bond to fund the payment of certain portions of the District's outstanding bond interest and principal payments and to supply the funds for our 2018 capital projects (our rollover bond), which will be issued as Limited Bonds on December 1, 2017.

The District has already held a duly advertised Bond Issue Notification Act (BINA) public meeting authorizing the intent to issue these bonds.

Implications

The ordinance provides for the general parameters of the bond issue including interest rate and final bond size that will be finalized upon sale of the bond. The bond is expected to close on December 1, 2017.

ORDINANCE 017-005

This is the official document providing for the issuance and sale of general obligation limited tax park bonds in an aggregate principal amount not to exceed \$2,750,000 for the purposes of (a) paying debt service on the District's outstanding debt, (b) paying for capital projects in the District, and (c) paying costs of issuances and incidental expenses.

Recommendation

That the A&F Committee recommend to the full board approval of ordinance O17-005 for the issuance of \$2,750,000 of Limited Bonds.

ORDINANCE NO. 017-005

AN ORDINANCE PROVIDING FOR THE ISSUANCE OF GENERAL OBLIGATION LIMITED TAX PARK BONDS, SERIES 2017B, OF THE HOFFMAN ESTATES PARK DISTRICT, COOK COUNTY, ILLINOIS, IN AN AMOUNT NOT TO EXCEED \$2,750,000 AND FOR THE LEVY OF A DIRECT TAX SUFFICIENT TO PAY THE PRINCIPAL AND INTEREST ON SAID BONDS.

WHEREAS, the Hoffman Estates Park District, Cook County, Illinois (the "District"), is a duly organized and existing municipality operating under the provisions of the Park District Code, as amended, and under the laws of the State of Illinois; and

WHEREAS, the District has previously issued: (i) Taxable General Obligation Bonds (Alternate Revenue Source), Series 2010A (Build America Bonds); (ii) General Obligation Bonds (Alternate Revenue Source), Series 2010C; (iii) General Obligation Park Bonds (Alternate Revenue Source), Series 2013A; and (iv) General Obligation Park Bonds (Alternate Revenue Source), Series 2014A (collectively, the "Refunded Bonds"); and

WHEREAS, the Board of Park Commissioners of the District (the "Board") has determined that it is necessary and in the best interests of the residents of the District to issue general obligation limited tax bonds of the District in the principal amount of not to exceed \$2,750,000 known as its "General Obligation Limited Tax Park Bonds, Series 2017B" (or such other designation as set forth in the Bond Order (hereinafter defined)) (the "Bonds") to: (i) refund all or a portion of the Refunded Bonds (the "Refunding"), (ii) pay for capital projects in the District (the "Projects"), and (iii) pay for the costs of issuance of and incidental expenses incurred in connection with the issuance of the Bonds, all for the benefit of the inhabitants of the District; and

WHEREAS, on October 27, 2015, the Board held a public hearing pursuant to the Bond Issuance Notification Act following notice published in the Daily Herald, a newspaper of general circulation in the District, on October 16, 2015; and

WHEREAS, the Board determines that it is necessary that the District borrow an aggregate amount not to exceed \$2,750,000 and issue the Bonds pursuant to 70 ILCS 1205/6-2; and

WHEREAS, the amount of outstanding non-referendum general obligation bonds of the District, including the proposed Bonds, will not exceed 0.575% of the aggregate assessed valuation of all taxable property within the District; and

WHEREAS, the District is authorized to issue limited bonds payable from the debt service extension base, as defined in the Property Tax Extension Limitation Law, and the Bonds are being issued as limited bonds as provided in 30 ILCS 350/15.01; and

WHEREAS, the Board now finds that it is necessary and advisable to proceed forthwith to provide for the issuance of the Bonds;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE HOFFMAN ESTATES PARK DISTRICT, COOK COUNTY, ILLINOIS, AS FOLLOWS:

Section 1. <u>Incorporation of Preamble.</u> The Board hereby finds that all of the recitals contained in the preambles to this ordinance are full, true and correct and does hereby incorporate such recitals into this ordinance by this reference.

Section 2. <u>Findings; Issuance of Bonds.</u> The Board hereby finds and determines that it is necessary and in the best interest of the District that the Bonds be issued to fund the Refunding,

to fund the Projects, and to pay the costs of the District in connection with the issuance of the Bonds.

There shall be borrowed on the credit of and for and on behalf of the District, the aggregate principal amount of not to exceed \$2,750,000 and that the District shall issue in the name of the District the Bonds pursuant to the Park Code for the purpose of funding the Refunding, the Projects, and the costs of issuance of the Bonds.

The Bonds shall be issued in the denomination of Five Thousand Dollars (\$5,000) or integral multiples thereof, or such other denomination upon the guidance of the District's municipal advisor, numbered consecutively from 1 upward and dated the date of delivery; and interest on the Bonds shall be payable on June 1, 2018, and semiannually thereafter. The Bonds shall be payable in lawful money of the United States of America, at the principal office of the Registrar and Paying Agent (as defined in Section 3 of this ordinance). The Bonds shall mature no later than on December 1, 2018, in the principal amount not to exceed \$2,750,000 and shall bear interest at a rate not to exceed 5.00% per annum (computed on a basis of a 360-day year of twelve 30-day months).

Interest on the Bonds shall be payable from the interest payment date to which interest has been paid next preceding the authentication date of the Bonds, unless the Bonds are authenticated after the fifteenth day preceding an interest payment date and on or before such interest payment date, in which case they shall bear interest from such interest payment date, or unless the Bonds are authenticated on or before May 15, 2018, in which case they shall bear interest from the original date until the principal shall be fully paid. All payments of interest on the Bonds shall be paid by check, mailed one business day prior to the interest payment date to the registered owners thereof as the names appear as of the fifteenth day of the month preceding the interest payment

date and at the addresses as they appear on the registration books kept by the Registrar and Paying Agent or at such other address as is provided to the Registrar and Paying Agent in writing by such registered owner.

The exact interest rates shall be set forth in a bond order executed by the Board President following the sale of the Bonds (the "Bond Order").

Section 3. <u>Registrar and Paying Agent.</u> In the Bond Order, the President of the Board shall name either the treasurer of the District or a bank with an office in Illinois to serve as Registrar and Paying Agent for the Bonds (the "Registrar and Paying Agent"). The Registrar and Paying Agent is hereby charged with the responsibility of authenticating the Bonds.

Each Bond shall be transferable or exchangeable only upon the books of the District kept for that purpose at the designated corporate trust office of the Registrar and Paying Agent by the registered owner in person, or by its attorney duly authorized in writing, upon surrender of such Bond together with a written instrument of transfer or exchange satisfactory to the Registrar and Paying Agent duly executed by the registered owner, or its attorney duly authorized in writing, and thereupon a new fully registered bond or bonds in an authorized aggregate principal amount and of the same maturity, shall be executed and delivered in the name of the transferee or transferees or the registered owner, as the case may be, in exchange therefor. The costs of such transfer or exchange shall be borne by the District except for any tax or governmental charge required to be paid with respect to the transfer or exchange, which taxes or governmental charges are payable by the person requesting such transfer or exchange. The District and the Registrar and Paying Agent for the Bonds may treat and consider the person in whose name such Bonds are registered as the absolute owner thereof for all purposes, including for the purpose of receiving payment of, or on account of, the principal thereof and interest due thereon.

The Registrar and Paying Agent may at any time resign as registrar and paying agent upon giving 30 days' notice in writing to the District and by first class mail to each registered owner of the Bonds then outstanding, and such resignation will take effect at the end of such 30-day period or upon the earlier appointment of a successor registrar and paying agent by the District. Any such notice to the District may be served personally or sent by registered mail. The Registrar and Paying Agent may be removed at any time as registrar and paying agent by the District, in which event the District may appoint a successor registrar and paying agent. The District shall notify each registered owner of the Bonds then outstanding by first class mail of the removal of the Registrar and Paying Agent. Notices to the registered owners of the Bonds shall be deemed to be given when mailed by first class mail to the addresses of such registered owners as they appear on the registration books kept by the Registrar and Paying Agent.

Upon the appointment of any successor registrar and paying agent by the District, the President, the Treasurer or the Secretary are authorized and directed to enter into such agreements and understandings with such successor registrar and paying agent as will enable the institution to perform the services required of a registrar and paying agent for the Bonds. The President and Secretary are further authorized to pay such fees as the successor registrar and paying agent may charge for the services it provides as registrar and paying agent and such fees may be paid from the fund established to pay the principal and interest on the Bonds as fiscal agency charges.

Any predecessor registrar and paying agent shall deliver all of the Bonds and any cash or investments in its possession with respect thereto, together with the registration books, to the successor registrar and paying agent.

The District may determine that it is beneficial to the District to have the Bonds held by a central depository system pursuant to an agreement between the District and The Depository

Trust Company, New York, New York (the "Depository Trust Company") and have transfers of the Bonds effected by book-entry on the books of the central depository system ("Book Entry System"). The Bonds shall be initially issued in the form of a separate single authenticated fully registered Bond for the aggregate principal amount of each separate maturity of the Bonds. Upon initial issuance, the ownership of such Bonds shall be registered in the register kept by the Registrar and Paying Agent in the name of CEDE & CO., as nominee of the Depository Trust Company.

With respect to the Bonds registered in the register kept by the Registrar and Paying Agent in the name of CEDE & CO., as nominee of the Depository Trust Company, the District and the Registrar and Paying Agent shall have no responsibility or obligation to any other holders or owners (including any beneficial owner (the "Beneficial Owner")) of the Bonds with respect to (i) the accuracy of the records of the Depository Trust Company, CEDE & CO., or any Beneficial Owner with respect to ownership questions, (ii) the delivery to any bondholder (including any Beneficial Owner) or any other person, other than the Depository Trust Company, of any notice with respect to the Bonds including any notice of redemption, or (iii) the payment to any bondholder (including any Beneficial Owner) or any other person, other than the Depository Trust Company, of any amount with respect to the principal of, or premium, if any, or interest on the Bonds except as otherwise provided herein.

So long as the Bonds are registered in the name of CEDE & CO., as nominee of the Depository Trust Company, no person other than the Depository Trust Company shall receive an authenticated Bond evidencing an obligation of the District to make payments of the principal of and premium, if any, and interest on the Bonds pursuant to this ordinance. The District and the Registrar and Paying Agent may treat as and deem the Depository Trust Company or CEDE &

CO, to be the absolute bondholder of each of the Bonds for the purpose of (i) payment of the principal of and premium, if any, and interest on such Bonds; (ii) giving notices of redemption and other notices permitted to be given to bondholders with respect to such Bonds; (iii) registering transfers with respect to such Bonds; (iv) obtaining any consent or other action required or permitted to be taken of or by bondholders; (v) voting; and (vi) for all other purposes whatsoever. The Registrar and Paying Agent shall pay all principal of and premium, if any, and interest on the Bonds only to or upon the order of the Depository Trust Company, and all such payments shall be valid and effective fully to satisfy and discharge the District's and the Paying Agent's obligations with respect to principal of and premium, if any, and interest on the Bonds to the extent of the sum or sums so paid. Upon delivery by the Depository Trust Company to the District of written notice to the effect that the Depository Trust Company has determined to substitute a new nominee in place of CEDE & CO., and subject to the provisions herein with respect to consents, the words "CEDE & CO." in this ordinance shall refer to such new nominee of the Depository Trust Company. Notwithstanding any other provision hereof to the contrary, so long as any Bond is registered in the name of CEDE & CO., as nominee of the Depository Trust Company, all payments with respect to the principal of and premium, if any, and interest on such Bonds and all notices with respect to such Bonds shall be made and given, respectively, to the Depository Trust Company as provided in a representation letter from the District to the Depository Trust Company (the "Blanket Issuer Letter of Representations").

Upon receipt by the District of written notice from the Depository Trust Company to the effect that the Depository Trust Company is unable or unwilling to discharge its responsibilities and no substitute depository willing to undertake the functions of the Depository Trust Company hereunder can be found which is willing and able to undertake such functions upon reasonable

and customary terms, then the Bonds shall no longer be restricted to being registered in the register of the District kept by the Registrar and Paying Agent in the name of CEDE & CO., as nominee of the Depository Trust Company, but may be registered in whatever name or names the bondholders transferring or exchanging the Bonds shall designate, in accordance with the provisions of this ordinance.

If the District determines that it is in the best interest of the bondholders that they be able to obtain certificates for the fully registered Bonds, the District may notify the Depository Trust Company and the Registrar, whereupon the Depository Trust Company will notify the Beneficial Owners of the availability through the Depository Trust Company of certificates for the Bonds. In such event, the Registrar shall prepare, authenticate, transfer and exchange certificates for the Bonds as requested by the Depository Trust Company and any Beneficial Owners in appropriate amounts, and whenever the Depository Trust Company requests the District and the Registrar and Paying Agent to do so, the Registrar and Paying Agent and the District will cooperate with the Depository Trust Company by taking appropriate action after reasonable notice to (i) make available one or more separate certificates evidencing the fully registered Bonds of any Beneficial Owner's Depository Trust Company account, or (ii) arrange for another securities depository to maintain custody of certificates for and evidencing the Bonds.

If the Bonds shall no longer be restricted to being registered in the name of the Depository Trust Company, the Registrar and Paying Agent shall cause said Bonds to be printed in blank in such number as the Registrar and Paying Agent shall determine to be necessary or customary; provided, however, that the Registrar and Paying Agent shall not be required to have such Bonds printed until it shall have received from the District indemnification for all costs and expenses associated with such printing.

Section 4. Redemption. The Bonds shall be subject to redemption as set forth in the Bond Order.

Section 5. <u>Execution and Negotiability.</u> Each of the Bonds shall be executed in the name of the District by the manual or facsimile signature of the President, and the seal of the District shall be affixed, imprinted, engraved or otherwise reproduced thereon and attested by the manual or facsimile signature of the Secretary; and these officials, by the execution of a General Certificate, shall adopt as and for their own proper signatures the facsimile signatures appearing on the Bonds. In case any officer whose signature or facsimile signature appears on the Bonds shall cease to be such officer before the delivery of the Bonds, the signature of such officer shall nevertheless be valid and sufficient for all purposes the same as if such officer had remained in office until such delivery.

The Bonds shall have all of the qualities and incidents of negotiable instruments under the laws of the State of Illinois, subject to the provisions for registration herein. The Bonds shall also be authenticated by the manual signature of the Registrar and Paying Agent and no Bond shall be valid or become obligatory for any purpose until the certificate of authentication thereon has been so executed.

Section 6. <u>Form of Bonds.</u> The form and tenor of the Bonds shall be substantially as follows, all blanks to be filled in properly prior to delivery:

This bond is subject to defeasance prior to payment as provided in the Ordinance referred to herein. THE OWNER OF THIS BOND, BY THE ACCEPTANCE HEREOF, HEREBY AGREES TO ALL THE TERMS AND PROVISIONS CONTAINED IN THE ORDINANCE.

The bonds maturing in any one year are issuable only in fully registered form in the denomination of \$5,000 and increments thereof.

If the payment date occurs on a date when financial institutions are not open for business, the wire transfer shall be made on the next succeeding business day. The Registrar and Paying Agent shall wire transfer payments so such payments are received at the depository by 2:30 p.m. (New York City time). All payments on the bond shall be made in any coin or currency of the United States of America, which on the dates of such payment, shall be legal tender for the payment of public and private debts.

This bond is a general obligation of the District payable from ad valorem taxes to be levied on all taxable property within the District without limitation as to rate. The amount of said taxes that may be extended to pay this bond is, however, limited as provided by law to the debt service extension base (as defined in the Property Tax Extension Limitation Law of the State of Illinois, as amended) (the "Base"). The District is authorized to issue from time to time additional limited bonds payable from the Base and additional non-referendum bonds payable from property taxes unlimited as to rate or amount, as permitted by law, and to determine the lien priority of payments to be made from the Base to pay the District's limited bonds. This bond is negotiable, subject to registration provisions, pursuant to the laws of the State of Illinois.

It is hereby certified and recited that all acts, conditions and things required to be done precedent to and in the execution, issuance and delivery of this bond have been done and performed in regular and due form as provided by law; that the indebtedness of the District, including the issue of the Bond of which this is one, does not exceed any limitation imposed by law; and that provision has been made for the collection of a direct annual tax sufficient to pay the interest hereon as it falls due and also to pay and discharge the principal hereof at maturity.

This bond shall not be valid or become obligatory for any purpose until the certificate of authentication hereon shall have been executed by an authorized representative of the Registrar.

Section 7. <u>Authorization for Preparation and Sale of the Bonds; Purchase Contract.</u>

The Treasurer is hereby authorized and directed to have the Bonds prepared, and the President and the Secretary are hereby authorized and directed to execute and attest the Bonds in the form and manner provided herein. The Treasurer is hereby authorized and directed to deliver the Bonds to the purchaser thereof (the "Purchaser"), upon completion of negotiation of the terms of the sale and receipt of the purchase price therefor in the amount of not less than 97% of the par amount of

the Bonds or greater than 102% of the par amount of the Bonds. The President and Secretary are hereby authorized to execute a contract for the sale of the Bonds containing terms not inconsistent with the terms of this Ordinance (the "Purchase Contract"), provided that (i) the President finds and determines that the Bonds will be sold at such price and bear interest at such rates that neither the true interest cost (yield) nor the net interest rate received upon such sale exceed the maximum rate otherwise authorized by Illinois law, (ii) the Purchase Contract is in the best interests of the District, and (iii) no person holding any office of the District, either by election or appointment, is in any manner financially interested directly, in his or her own name, or indirectly, in the name of any other person, association, trust or corporation, in the Purchase Contract. Before being issued, the Bonds shall be registered and numbered, such registration being made in a book provided for that purpose, in which shall be entered a description of the Bonds issued, including the number, date, to whom issued, amount, rate of interest and when due. The Bonds shall be executed as in this ordinance provided as soon after the execution of the Purchase Contract as may be done, and thereupon the Bonds shall be deposited with the Treasurer who receives the taxes of the District, and be by said Treasurer delivered to the Purchaser upon receipt of the purchase price therefor.

The Bonds when fully paid for and delivered to the Purchaser, shall be the binding general obligations of the District. The proper officers of the District are hereby directed to sell the Bonds to the Purchaser and to do whatever acts and things which may be necessary to carry out the provisions of this ordinance.

Section 8. <u>Official Statement.</u> The President is authorized to approve a form of Preliminary Official Statement for the Bonds, or such other offering material relating to the issuance and sale of the Bonds upon the guidance of the District's municipal advisor, and to deem it nearly final, and the President is hereby authorized and directed to execute the final Official

Statement or other offering material after the sale of the Bonds to the Purchaser.

Section 9. Tax Levy. In order to provide for the collection of a direct annual tax sufficient to pay the interest on the Bonds as it falls due and also pay and discharge the principal thereof at maturity, there shall be levied upon all the taxable property within the District a direct annual tax (the "Pledged Taxes") for each of the years in which the Bonds are outstanding, in amounts sufficient for those purposes, and that there be and there is hereby levied upon all of the taxable property in the District, in addition to all other taxes, a direct annual tax in the years and amounts as set forth in the Bond Order.

Principal or interest coming due at any time when there are not sufficient funds on hand from the foregoing tax levy to pay the same shall be paid from current funds on hand of the District, and the fund from which such payment was made shall be reimbursed out of the taxes hereby levied when the same shall be collected.

The District covenants and agrees with the Purchaser and the holders of the Bonds that so long as the Bonds remain outstanding, the District will take no action or fail to take any action which in any way would adversely affect the ability of the District to levy and collect the foregoing tax levy, unless the abatement of any particular tax levy amount has been provided for through the deposit of moneys in a segregated account, and the District and its officers will comply with all present and future applicable laws in order to assure that the foregoing taxes will be levied, extended and collected as provided herein and deposited in the Bond Fund (as defined in Section 12 of this ordinance) established to pay the principal of and interest on the Bonds.

The funds derived from the tax levy be and the same are hereby appropriated and set aside for the sole and only purpose of paying principal and interest on the Bonds when and as the same become due. The funds from the sale of the Bonds be and they are hereby appropriated and set aside for the purposes hereinbefore set out.

If the District deposits funds from any lawful source into the Bond Fund, the Secretary shall file written direction with the County Clerk to abate the taxes by the amount so deposited, and such deposits shall be made prior to any such abatement being filed with the County Clerk. No Pledged Taxes may be abated unless and until the proper amount of such abatement has been deposited irrevocably into the Bond Fund and dedicated to the payment of the Bonds.

Secretary is hereby directed to file a certified copy of this ordinance, which certificate shall recite that this ordinance has been passed by the Board and published, with the County Clerk of Cook County (the "County Clerk"), and it shall be the duty of said County Clerk to ascertain in each tax year that the Bonds are outstanding the rate necessary to produce the tax herein and therein levied, and extend the same for collection on the tax books against all of the taxable property within the District in connection with other taxes levied in said years, in order to raise the amount aforesaid and in said years such annual tax shall be computed, extended and collected in the same manner as now or hereafter provided by law for the computation, extension and collection of taxes for general corporate purposes of the District, and when collected, the taxes hereby levied shall be used only for the purpose of paying the principal of and interest on the Bonds.

Section 11. <u>Bond Proceeds.</u> A portion of the proceeds of the Bonds shall be used for the Refunding of the Refunded Bonds and shall be used solely for the Refunding. Any proceeds of the Bonds remaining upon completion of the Refunding shall be deposited in the Capital Project Fund (as defined in Section 13 of this ordinance) and used to fund the Projects and to pay costs of issuance.

Section 12. <u>Bond Fund.</u> There is hereby created and established a special fund of the District known as the "2017B Bond Fund" (the "Bond Fund") to be held by the Treasurer, which is a trust fund established for the purpose of carrying out the covenants, terms and conditions imposed upon the District by this ordinance. The Bond Fund shall be the fund for the payment of the principal of and interest on the Bonds at maturity or on interest payment dates or redemption. Any capitalized or accrued interest included in the proceeds of the sale of the Bonds shall be deposited in the Bond Fund for the payment of interest on the Bonds, and Pledged Taxes shall be deposited into the Bond Fund, as received, and shall be used solely and only for the payment of principal and interest on the Bonds when due (including any redemption). The Bonds are secured by a pledge of all moneys on deposit in the Bond Fund, and such pledge is irrevocable until the Bonds have been paid in full or until the obligations of the District are discharged under this ordinance.

Section 13. <u>Capital Project Fund.</u> There is hereby created and established a special fund of the District known as the "2017B Capital Project Fund" (the "Capital Project Fund") to be held by the Treasurer of the District. Said fund is to be used for the financing of the Projects. In the event that any moneys remain in the Capital Project Fund upon completion of the Projects, the District shall use such money for additional capital improvements within the District or deposit the remaining moneys in the Bond Fund in which case such moneys shall be used to pay the principal of and interest on the Bonds on the earliest possible date.

Section 14. <u>Escrow Fund.</u> There is hereby established a special fund of the District known as the "2017B Escrow Fund" (the "Escrow Fund") to be held by the Treasurer. There shall be deposited in the Escrow Fund the proceeds of the Bonds in an amount sufficient to effect the

Refunding. The Escrow Fund shall be maintained separate and apart from all other accounts of the District. Moneys in the Escrow Account shall be used to complete the Refunding.

Section 15. <u>Additional Funds and Accounts.</u> In addition to the funds established hereunder, the President is hereby authorized and directed to establish, and the Treasurer is further authorized to hold, any and all funds and/or accounts they deem necessary or convenient to the accomplishment of the purposes set forth in this ordinance.

Section 16. Defeasance of the Bonds. If, when the Bonds or a portion thereof shall have become due and payable in accordance with their terms or shall have been duly called for redemption or irrevocable instructions to call the Bonds or a portion thereof for redemption shall have been given, and the whole amount of the principal and the interest and the premium, if any, so due and payable upon all of the Bonds or a portion thereof then outstanding shall be paid; or (i) sufficient moneys or (ii) direct obligations of the United States of America (including obligations issued or held in book entry form on the books of the Department of the Treasury), the principal of and the interest on which when due will provide sufficient moneys for such purpose, shall be held in trust for such purpose, and provision shall also be made for paying all fees and expenses for the redemption, then and in that case the Bonds or any designated portion thereof issued hereunder shall no longer be deemed outstanding or entitled to any pledge of the Pledged Taxes made herein.

Section 17. Amendments with Consent of Bondholders. Subject to the terms and provisions contained in this section, and not otherwise, the owners of not less than sixty-six and two-thirds percent ($66^{2}/_{3}\%$) in aggregate principal amount of the Bonds issued pursuant to this ordinance and then outstanding shall have the right from time to time, anything contained in this ordinance to the contrary notwithstanding, to consent to and approve the adoption by the District

of such ordinance or ordinances supplemental hereto or amendatory hereof, as shall be deemed necessary or desirable by the District for the purpose of modifying, altering, amending, adding to or rescinding in any particular manner any of the terms or provisions contained in this ordinance, or in any supplemental ordinance; provided, however, that nothing herein contained shall permit or be construed as permitting:

- (a) An extension of the maturity of the principal of or interest on any Bond issued pursuant to this ordinance; or
 - (b) A reduction in the principal amount of any Bond or the rate of interest thereon; or
- (c) A preference or priority of any Bond or Bonds issued pursuant to this ordinance over any other Bond or Bonds issued pursuant to the provisions of this ordinance; or
- (d) A reduction in the aggregate principal amount of the Bonds required for consent to such supplemental ordinance.

If the owners of not less than sixty-six and two-thirds percent (66 ²/₃%) in aggregate principal amount of the Bonds outstanding at the time of adoption of such supplemental ordinance shall have consented to and approved the adoption thereof by written instrument to be maintained on file in the office of the Secretary, no owner of any Bond issued pursuant to this ordinance shall have any right to object to the adoption of such supplemental ordinance or to object to any of the terms and provisions contained therein or the operation thereof, or in any manner to question the propriety of the adoption thereof, or to enjoin or restrain the District from adopting the same, or from taking any action pursuant to the provisions thereof. Upon the adoption of any supplemental ordinance pursuant to the provisions of this section, this ordinance shall be, and shall be deemed, modified and amended in accordance therewith, and the respective rights, duties and obligations under this ordinance of the District and all owners of Bonds then

outstanding, shall thereafter be determined, exercised and enforced in accordance with this ordinance, subject in all respects to such modifications and amendments. Notwithstanding anything contained in the foregoing provisions of this ordinance, the rights and obligations of the District and of the owners of the Bonds authorized by this ordinance, and the terms and provisions of the Bonds and this ordinance, or any supplemental or amendatory ordinance, may be modified or altered in any respect with the consent of the District and the consent of the owners of all the Bonds then outstanding:

Section 18. <u>Tax Covenants.</u> In order to preserve the exclusion of interest on the Bonds from gross income for federal tax purposes under Section 103 of the Internal Revenue Code of 1986 as existing on the date of issuance of the Bonds (the "Code") and as an inducement to purchasers of the Bonds, the District represents, covenants and agrees that:

(a) The projects financed with the proceeds of the Bonds will be available for use by members of the general public. Use by a member of the general public means use by natural persons not engaged in a trade or business. No person or entity, other than the District or another state or local governmental unit, will use more than ten percent (10%) of the proceeds of the Bonds or property financed by the Bond proceeds other than as a member of the general public. No person or entity other than the District or another state or local governmental unit will own property financed by Bond proceeds or will have actual or beneficial use of such property pursuant to a lease, a management or incentive payment contract, an arrangement such as a take-or-pay or output contract or any other type of arrangement that conveys other special legal entitlements and differentiates that person's or entity's use of such property from the use by the general public, unless such uses in the aggregate relate to no more than ten percent (10%) of the proceeds of the Bonds. If the District enters into a management contract for the Projects, the

terms of the contract will comply with IRS Revenue Procedure 97-13, as it may be amended, supplemented or superseded from time to time, so that the contract will not give rise to private business use under the Code and the Regulations, unless such use in aggregate relates to no more than ten percent (10%) of the proceeds of the Bonds.

- (b) No more than ten percent (10%) of the payment of the principal of or interest on the Bonds will be (under the terms of the Bonds, this ordinance or any underlying arrangement), directly or indirectly, (i) secured by any interest in property used or to be used for a private business use or payments in respect of such property or (ii) derived from payments (whether or not to the District) in respect of such property or borrowed money used or to be used for a private business use.
- (c) No more than five percent (5%) of the Bond proceeds will be loaned to any entity or person other than a state or local governmental unit. No more than five percent (5%) of the Bond proceeds will be transferred, directly or indirectly, or deemed transferred to a nongovernmental person in any manner that would in substance constitute a loan of the Bond proceeds.
- (d) The District reasonably expects, as of the date hereof, that the Bonds will not meet either the private business use test described in paragraphs (a) and (b) above or the private loan test described in paragraph (c) above during the entire term of the Bonds.
- (e) No more than five percent (5%) of the proceeds of the Bonds will be attributable to private business use as described in (a) and private security or payments described in (b) attributable to unrelated or disproportionate private business use. For this purpose, the private business use test is applied by taking into account only use that is not related to any government

use of proceeds of the issue (Unrelated Use) and use that is related but disproportionate to any governmental use of those proceeds (Disproportionate Use).

- (f) Neither the District nor the Board will take any action or fail to take any action with respect to the Bonds that would result in the loss of the exclusion from gross income for federal tax purposes on the Bonds pursuant to Section 103 of the Code, nor will the District or the Board act in any other manner which would adversely affect such exclusion.
- (g) It shall not be an event of default under this ordinance if the interest on any Bond is not excludable from gross income for federal tax purposes or otherwise pursuant to any provision of the Code which is not currently in effect and in existence on the date of issuance of the Bonds.
- (h) The District certifies that to the extent necessary to preserve the exclusion from gross income of interest on the Bonds for federal tax purposes, it will rebate any arbitrage profits to the United States of America in accordance with Section 148(f) of the Code and the Regulations promulgated thereunder.
- (i) These covenants are based solely on current law in effect and in existence on the date of delivery of such Bonds. The District hereby authorizes the officials of the District responsible for issuing the Bonds, the same being the President and the Secretary, to make such further covenants and certifications as may be necessary to assure that the use thereof will not cause the Bonds to be arbitrage bonds and to assure that the interest on the Bonds will be excludable from gross income for federal income tax purposes. In connection therewith, the District further agrees: (a) through its officers, to make such further specific covenants, representations as shall be truthful, and assurances as may be necessary or advisable; (b) to consult with counsel approving the Bonds; (c) to pay to the United States, as necessary, such

sums of money representing required rebates of excess arbitrage profits relating to the Bonds as required pursuant to Section 148 of the Code and the regulations promulgated thereunder; (d) to file such forms, statements, and supporting documents as may be required and in a timely manner; and (e) if deemed necessary or advisable by their officers, to employ and pay fiscal agents, municipal advisors, attorneys, and other persons to assist the District in such compliance.

Section 19. <u>Noncompliance with Tax Covenants.</u> Notwithstanding any other provisions of this ordinance, the covenants and authorizations contained in this ordinance (the "Tax Sections") which are designed to preserve the exclusion of interest on the Bonds from gross income under federal law (the "Tax Exemption") need not be complied with if the District receives an opinion of nationally recognized bond counsel that any Tax Section is unnecessary to preserve the Tax Exemption.

Section 20. Registered Form. The District recognizes that Section 149(a) of the Code requires the Bonds to be issued and to remain in fully registered form in order that interest thereon is exempt from federal income taxation under laws in force at the time the Bonds are delivered, In this connection, the District agrees that it will not take any action to permit the Bonds to be issued in, or converted into, bearer or coupon form.

Section 21. <u>Professional Services.</u> The District shall retain Austin Meade Financial Ltd. to serve as municipal advisor and Taft Stettinius & Hollister LLP to serve as bond counsel in connection with the issuance of the Bonds.

Section 22. <u>Severability.</u> If any section, paragraph or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph or provision shall not affect any of the remaining provisions of this ordinance.

Section 23. <u>Publication.</u> The Secretary is hereby authorized and directed to publish this ordinance in pamphlet form and to file copies thereof for public inspection in his/her office.

Section 24. <u>Conflicting Ordinances</u>. All ordinances, resolutions and parts of ordinances and resolutions, in conflict herewith are hereby repealed.

Section 25. <u>Headings.</u> The headings or titles of the several sections shall be solely for convenience of reference and shall not affect the meaning, construction or effect of this ordinance.

Section 26. <u>Effective Date.</u> This ordinance shall be in full force and effect from and after its adoption and publication.

A. Finance/Administration

VSI RecTrac 3.1

- Staff developed a 50 page RecTrac service desk training guide with instructional how-to and processing exercises to ensure service desk staff are prepared when the District goes LIVE.
- Staff is working on menu consolidation and touch screen menus to ensure a smooth transition to new version 3.1 software.
- Staff has balanced all unearned income and receivables as tracked with VSI RecTrac software through September 2017.
- Staff is working with facility managers to purge facility options that are no longer used.
- Staff has been looking into other credit card gateway processors as it doesn't
 appear that Plug-n-pay, the current gateway processor, will have chip technology
 based equipment in the near future. The gateway processor needs to work with
 VSI RecTrac software and also needs to be able to extract the District's billing
 information from Plug-n-pay. To ensure the District's success in this process, it is
 anticipated that chip readers may not be available before year-end.
- Staff is finalizing our budgeted 2006 bond refunding. This has been in the works a long time and we have identified that the market is now in a good position to put this out for bid (now that Illinois has a budget and prior to potential federal interest rate hike in December). The bond refunding is being bid on Thursday, October 19th. It is anticipated that the District will be able to achieve an interest rate of approximately 3% which will allow for present value savings of approximately \$700,000. This bond not only provides these savings, which have been converted to additional bond proceeds for future capital projects, but the bond refunding was the final component to allow for a consistent annual bond issue to provide approximately \$750,000 each year for District capital projects.
- Staff is preparing for our annual December bond issue that provides debt service funding and new monies for next year's capital projects. The ordinance for this December 1, 2017 issue is being presented to the A&F Committee this month.
- Attended Illinois Legislator Update sponsored by the Chamber. Six legislators
 were present and provided insight into some of the pressing state issues they are
 facing.
- Staff attended NRPA congress in New Orleans and has submitted session recaps on educational sessions that were attended. Highlights will be presented at the November committee meetings.
- Attended PDRMA Health Program Council. New health insurance rates were provided that the District will have in 2018. Costs increased approximately 4%.

- Held green team meeting to explore options for environmental efficiencies to be budgeted for in 2018. Committee voted to pursue water bottle dispensers to add to drinking fountains at facility locations.
- Staff is finalizing budget for the November Committee of the Whole meeting.
