SCOPE OF WORK STEEL

The specifications and drawings are to govern the extent of the Work required or reasonably incidental to this Bid package. The following list of Work items is to be included and considered complementary to the drawings and specifications:

Furnish all labor, tools, material, and equipment required and necessary to complete the following:

- 1. Supply and install all structural steel and miscellaneous iron including columns, tubes, beams, joist, trusses, lintels, purlins, structural shapes, channels, angles, embedded items, bolts, fasteners.
- 2. Provide all bidding and contract requirements: General Requirements, Structural Steel, Steel Joists, Metal Fabrications, and related sections as specified.
- 3. Provide all layouts along with concrete contractor required for the correct installation of steel members in a proper alignment.
- 4. All steel shall be erected, braced, level and plumb.
- 5. Partial deliveries and installations should be anticipated and will be required to meet the schedule..
- 6. Provide shop painting and field touch up.
- 7. Provide to concrete contractor all anchor bolts and setting plates.
- 8. Provide all hoisting necessary and required for completion of this project. Adequate provisions must be taken to protect the existing underground utilities. Existing exterior window on eastside of building will be removed by owner to allow the passing and setting of new interior steel. Note the owner will remove one widow on the eastside of the building for use by the Steel Contractor as a pass thru for structure steel. The owner will replace the window at his expense. The steel contractor shall protect the existing masonry, window frame and sill from damage cause by transport of new steel members into the interior space.
- 9. Supply all anchor devices and other embedded items that are attached to or supported by new cast in place concrete.
- 10. Equipment and manpower shall be provided in suitable size and number to satisfy and complete the work according to site material conditions, schedule and weather.
- 11. This facility must remain in operation, including all services, at all times. All work must be closely coordinated with Owner requirements, which shall take precedence. Trade contractor shall anticipate and have auxiliary work to fall back to should an area be temporarily closed to work.
- 12. Provide adequate staff to review the Contract Documents and request, in writing, any additional information required well in advance of the actual fabrication or installation. Coordinate and communicate installation information with all other trades where there is interface, connection or contact with a product or work being installed and/or supplied by others.
- 13. If this Contractor is determined to impede the progress of the project schedule, the work delaying such progress will be passed over in a normal course of business and this Contractor shall be responsible for installing the work under other means and paying for additional costs, remedial work or damages resulting from such action.
- 14. Provide markers indicating limits of work and clear identification of items and areas requiring protection. Provide barricades, warning signs, and warning lights at conditions where there is a danger of injury to persons, or materials falling into excavations, pits, or depressions in the surrounding grade. This contractor is solely responsible for determining the potential for injury to persons and damage to property. Where such potential is present, take appropriate protective measures. Protect persons from injury and protect existing and new improvements from damage caused directly or indirectly by construction operations.
- 15. The Trade Contractor shall be liable and responsible for payment of all OSHA fines and/or other penalties against their work for failure to comply with all such requirements. Trade Contractor shall also reimburse the Construction Manager for all OSHA and other fines and/or penalties charged to the construction manager due to Trade Contractor's negligence.
- 16. Clean up shall be on a daily basis. This shall include sweeping and other housekeeping methods necessary to maintain the building, and removal of debris from streets, roads, and landscaped

- areas. All unused materials, packaging, debris, food-related items shall be placed in rubbish containers and daily removed from the site.
- 17. Submit the following information within five (5) days after bidding, when requested: a) average size crew anticipated; b) approximate number of man-days anticipated for each major function of work; c) delivery dates of major equipment or fixtures; and, e) references and financial qualifications. All shop drawings shall be submitted within twenty-one (21) days of the Contract date.
- 18. No extras shall be accepted on this project unless initiated by the Owner. Discrepancies, exclusions, clarifications regarding each contractor's scope of work shall be addressed by contractor, in writing, and to the architect during the bidding process.
