MAPLE PARK PLAYGROUND FENCING *105 Illinois Blvd.*

Standard 4ft high Black Aluminum Ornamental Fence as per plans, details and specs. 375 lin. Ft. 4 ft high, 65 -2" square posts and 2- 5" square gate posts, one 3'6" entry gate with locinox self-closing hinges and locinox LAKZ P1 WSI gate lock with receiver, one 10 ft wide access gate consisting of two 5 foot leaf sections, locking pin and latch to accommodate a pad lock. All posts to be cored into existing concrete curb or slab.

Standard 4ft high Black Vinyl Chain Link Fence as per plans, details and specs. 375 lin. Ft. 4 ft high, 65 -2" round posts, 2- 5" round gate posts, one 3'6" entry gate with locinox self-closing hinges and locinox LAKZ P1 WSI gate lock with receiver, one 10 ft wide access gate consisting of two 5 foot leaf sections, locking pin and latch to accommodate a pad lock. All posts to be cored into existing concrete curb or slab.

EVERGREEN PARK PLAYGROUND FENCING *600 Washington Blvd.*

Standard 4ft high Black Vinyl Chain Link Fence as per plans, details and specs. 320 lin. Ft. 4 ft high, 50 -2" round posts, 2- 5" round gate posts, one 3'6" entry gate with locinox self-closing hinges and locinox LAKZ P1 WSI gate lock with receiver, one 10 ft wide access gate consisting of two 5 foot leaf sections, locking pin and latch to accommodate a pad lock. Posts to be set 42" minimum depth concrete footings except for the four posts located around the access entry gate. Those posts are to be cored into the existing concrete walk and grouted as per specifications.

ITEM 3

HIGH POINT PARK TENNIS COURT ENTRY GATE RE-LOCATION *1704 Glenlake Rd.* Remove existing four foot wide entry gate hinges and all hardware. Fill in opening with black vinyl chain link that matches existing fabric. Install a new gate post and head rail to accommodate removed gate in new location. Re- install gate with all hardware. All new fence material shall be black vinyl to match existing fence.

ITEM 4A

HIGH POINT PARK RESTROOM WOODEN FENCE SCREEN WALL

Supply quantity 10 (ten) 2 -1/2" SS 40 galvanize posts 11 foot long to be set by concrete contractor. Supply and install all steel to wood post adapters, Furnish and install 3 (top, mid and bottom) 2"X 6" Cedar rails between galvanized posts and or existing building and posts (approximately 58 total feet). Furnish and install 2" X 8" X 7 foot high Board on Board (Shadow box) fence panels. Furnish and install one 5 foot wide shadow box gate section to match wall panels including all hinges and latch hardware. (8" Ameristar Maxima tee hinge & Ameristar universal gravity latch).

ITEM 4B

HIGH POINT PARK Cedar SPLIT RAIL FENCING

Supply and install Western Red Cedar posts and rails to form a three rail wooden fence as per plans and specifications. Rails to be classified as Jumbo (12" measurement around the rail). Rails to be a minimum of 10 ft long. All posts to be set into limestone screenings and tamped solid.

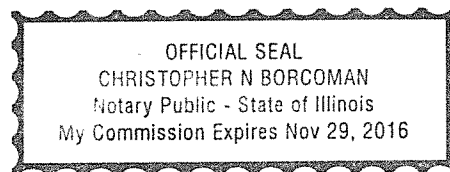
