Final payment will be made based on unit pricing of items installed and accepted by the district. For the basis of this proposal, estimated quantities of work have been provided so as to reflect the overall scope intent of the project. Contractor to remove 17 each - 10 foot high fence posts identified on map on the existing tennis court. Remove all existing concrete from posts identified to be re-placed and discard material appropriately. (Contractor may need to remove fabric so as not to damage fabric in removal process. Contractor may elect to replace existing fence posts with new fence posts to match existing instead of removing concrete from existing posts. Contractor to re-install and stretch existing fabric.) Contractor to excavate and flare post holes to a depth of no less than 42" below finish grade. Contractor to supply, place and set posts in 6 bag concrete according to industry standards. Contractor to stretch fence fabric and clean-up all waste materials and dispose of them properly.
