President Kaplan encouraged residents to take the issues that the park district could not address to the Village and the Township for answers.

Jodi Mitchell noted that the loss of open land was the most important issue to her and that she did not want more concrete. She explained that she wanted the original park to remain in its original state.

An unidentified homeowner said she would like to see the smaller park area for the kids be taken better care of. Executive Director Bostrom explained that they would replace the picnic table and look at the tree trimming and seeding outside of the playground area.
