## A. <u>CMP Process: FPC/M18-065:</u>

Executive Director Talsma reviewed the item noting that he was looking to complete this process in the next 18 months or by September 2019, prior to the 2020 budget process. He explained that there was a link on the website transparency page that offered the past CMP.

Comm Rep Sernett asked about the meaning of GIS and Executive Director Talsma explained it was a Geographical Information System or an inventory of the district's fixed assets and their replacement costs.

Comm Rep Macdonald asked about the definition of a stakeholder and Executive Director Talsma noted that it was people like the Mayor, etc.

No motion required as this was information only.

## B. <u>CMP Process: Needs Assessment Recommendation/M18-067:</u>

Executive Director Talsma reviewed the item noting that the needs assessment was the questionnaire that was sent to residents regarding the park district. He explained that staff had interviewed all the candidates and found ETC to be the most qualified.

Chairman Kilbridge noted that Ron Vine was always in attendance at conference and very involved with park districts.

Comm Rep Veronico made a motion, seconded by Comm Rep Wittkamp to recommend the Forward Planning committee recommend that the Board approve ETC be hired to conduct the Needs Assessment Survey in an amount not to exceed \$24,785. The motion carried by voice vote.

## Background

An integral component when updating the district's five year Comprehensive Master Plan is the implementation of a Needs Assessment Survey and the ultimate findings of the survey. ETC Institute will be preparing and mailing a Needs Assessment Survey in October to approx. 5,500 random community members. The purpose of this survey is to help determine park and recreation satisfaction and priorities within the community.

In order to create an informative and effective survey, ETC will be conducting several focus group meetings and stakeholder interviews with community leaders, residents and park district members and staff. One of the focus group meetings will be comprised of Commissioners and Community Representatives at the Forward Planning Committee on July 31<sup>st</sup>.
