4. Awards:

A. BOH:

Coach Mallory Whalen was awarded the BOH for her role as head soccer coach for grades 1-6 and her tremendous service to the kids and the district.

5. Comments from the Audience:

Mr. Katis distributed diagrams showing the current and proposed tennis/pickle ball courts at Fabbrini Park. He introduced himself to the board noting that he had been a Community Rep on the A&F Committee for many years, just recently moving. He also explained that he knew the district would be entering their budget process and wanted to present a plan to increase the number of pickle ball courts at Fabbrini from 6 to 10 requesting that the 2nd tennis court be replaced. He noted that pickle ball was the number one growing sport in the US and that Hoffman Estates had a great reputation in this field and hoped that the board would give consideration to the proposal.

Mr. Graba addressed the board noting that he and his wife has started the pickle ball program at The Club and set the standard for the State of Illinois. He explained that they average 40 – 60 players a day on only 4 courts 7 days a week and that the program had grown from 0 participants to over 400. He explained that they had outgrown the facility and were looking to expand.

President Kaplan thanked Mr. Katis and Mr. and Mrs. Graba for presenting their proposal noting that staff would look into the issue.

Commissioner Kilbridge asked if they were still using Olmstead and it was noted that there was some play there but the primary playing area was Fabbrini. Mr. Graba noted that nationally the sport had grown from 15,000 to 150,000 participants in 6 years. It was noted that they also played indoors at The Club (advanced players) and at TC (beginners and less advanced).

A. Public Hearing on Proposal to Sell Bonds/M19-085:

President Kaplan called the Bond Issue Notification Act or BINA Hearing to order at 7:55 p.m.

President Kaplan announced that the notice of the public BINA hearing was published in the Daily Herald on August 19, 2019 in accordance with the act. Proof of publication is to be included in the minutes.

He also explained that the purpose of the public BINA hearing is to provide members of the public the opportunity to provide comments to the Board on the proposed bonds and provided an overview of the Proposed General Obligation Limited Tax Park Bonds as follows:

Bonds will be issued in one or more series over the next three years.
The total amount of the bonds to be issued over the next three year in an aggregate amount not to exceed \$10,000,000.

Purpose of Bonds is to provide for capital improvements to and maintenance of park district facilities including but not limited to renovation of various park facilities, improvements to the golf course, the purchase of equipment and buildings, and paying any necessary costs of issuance and expenses incident thereto. Projects are initially identified in the District Capital Improvement Plan and Budget.

President Kaplan opened the floor for comment by the public. There were no comments.

Commissioner K. Evans made a motion, seconded by Commissioner McGinn to close the public hearing at 7:57 p.m. The motion carried by voice vote.

14. Commissioner Comments:

Commissioner K. Evans noted that he celebrated his birthday at Fabbrini Park and presented a picture painted of the park as a gift from his nephew.

Commissioner Kinnane noted that his children were back in school and he would become a regular again at district facilities.

Commissioner McGinn noted that he enjoyed the Volunteer Appreciation night at Seascape and the park tour.

Commissioner Kilbridge noted that she liked the extended pool hours.

Commissioner R. Evans said he liked the park tour and suggested offering it to residents and/or 50+ to introduce them to all the parks at the district. He also noted that he enjoyed the Village Green summer concert and asked if the district did not get more acknowledgement for our participation. Executive Director Talsma noted that the park district was mentioned in all the publications but staff will check on additional acknowledgement.

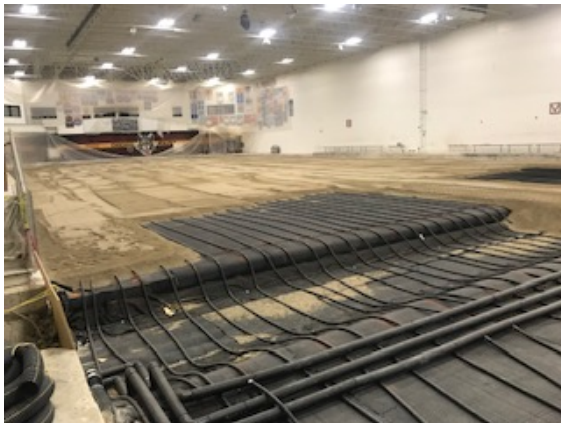

EXECUTIVE DIRECTOR'S REPORT

September 2019

PARKS DIVISION
ICE RINK

The ice rink has seen lots of progress in August. The construction of the rink has begun, it started with laying down the drainage boards that cover the entire rink and drain to a 4-inch tile that borders the rink and the header pit. These drain tiles will run to the drainage room where the storm water injector pit is located. It was identified that the sediment pit that drains into the injector pit was not installed at correct elevations and had to be replaced to provide proper pitch. Upon completion of this work the trenches that currently house the pipes to both rinks started to drain properly. Following the drainage boards was laying the heat pipes and headers for the heat system. This consists of two miles of black poly pipe fused into the headers. Rebar is then placed on top of the heat pipes to hold them in place followed by gravel screenings (which the photo below shows) and then two sheets of insulation and vapor barrier. Once the vapor barrier was placed they began to lay the metal chairs for cold floor rebar and piping, all the chairs were laid on the rink prior to 9/1/2019 and currently they are in the process of installing the rebar that the cold pipes will be tied to. The cold pipes install (13 miles of pipe) will begin on 9/9/2019.



COMMUNITY PARK

The playground at Community Park was opened to the public on 8/19/2019. The playground, which is a Playcore national demonstration site, features all six elements of play. It also features an arch swing, which has been a great hit with the children in the area. The old roller rink was converted into a half basketball court and kids asphalt obstacle course.

MAPLE PARK

The portion of land that was sold to Schaumburg Township is now a completed parking lot. We will now begin landscaping the roadway and end of the parking lot as well as setting the placement for the back stop. There were resident concerns about the placement of trees and saving of certain trees; with this in mind the township has done a great job of planting new shrubs and trees around the parking lot. A Hoffman Estates resident also paid to have the ash trees milled so that the district could use them for building of benches at Maple Park. District staff cut down the ash trees and took care of transporting to the mill; we now have the milled lumber at our shop and it must dry for one year prior to building the benches.



PARK GROUNDS

We welcomed a new member to the park grounds team this past month. Gail Fitch started on August 6, 2019 with the district. Gail came to us from Oak Park Park District, where he was the lead foreman for athletic field maintenance and has accepted our position of Athletic Field Manager.

Golf Maintenance Summary

In August our high averaged 80 degrees (1 degree below average) and low averaged 62 degrees (1 degree below average). Rainfall was substantial below average this month at 2.14" (4.9" average). We only saw measurable rain 9 days in August, of those only 5 had totals over .2" none were more than .5". In August we saw 25 total playable* days (80%) and weekends in August we had 7 playable* days (77%).

*Playable is being defined as highs between 55-90 degrees and less than .05" rain.

August is always a bitter sweet time of year. From a plant health stand point it is the last mile of the race that has been summer. As August progressed we saw lower day time temps and less daylight each day. These are all great things when you have turf that has been under environmental stress for the last month and a half. Very shortly we will start our fall aerification which will help push root growth and create a very strong plant for this fall and winter. August is also the time of year when the crew really tends to start firing on all cylinders; unfortunately it is also the time when staff normally starts to leave to return to school. As the staff dwindles we will continue to focus on mowing and detail items, it will just take us a little longer to complete everything.

Here is a small list of some of the tasks the maintenance team has been working on in August:

- Applied preventative fungicide and fertilizer applications on greens, tees, and fairways.
- Cultural practices; topdressed, verticut, and needle tined greens
- Trimmed bushes and maintained perennial beds around clubhouse and on course.
- Repaired multiple leaks in the irrigation system
- Worked on detail items; trimming trees, irrigation heads, and yardage plates.
- Trimmed and edged bunkers
- Trimmed up low branches on trees

- Filled divots on tees and fairways
- Worked to anchor down all dividers at the range
- Started mowing down tall fescue areas in preparation for herbicide application in late September

Facility Enhancement Planning Update

- Staff has begun the preparation of the bids for all flooring items: turf, sports flooring, carpet, and hardwood spring flooring. Bid documents will be going out Mid-September. We will have the option to reject all bids if necessary, Bids will not be awarded until 2020 budget is fully approved.

Ice Update

In the last two weeks, all the drainage for the new rink has been laid down. It consists of drainage boards that move the water to 4 inch drain tiles that are buried in pea gravel and covered with fabric. The heat pipes for the new rink have been installed and held pressure for 24 hours, they still need to be tested to hold pressure for 72 hours, which is taking place now. The gravel base that covers the heat pipes has been arriving all day today with a total of 24 semi loads to be delivered. This material will be spread over the entire rink and be the base layer prior to the insulation. In house crews along with US Water Solutions provided a new sediment pit for both rinks to properly drain into and avoid wet soils beneath the rink moving forward.
