#### A. Bridges Driving Range Enhancement Bids / M21-042:

Director Hugen reported that the bids received for the Bridges Driving Range Enhancement Project all were over the budgeted project amount. Staff is recommending that the following bids be rejected: - Concrete, Furniture and Tee Box Dispenser

Director Hugen is working with the low-qualified bidder on the building and furnishing (trim, ceilings, gas lines, electricity) bids to value engineer the project.

Comm Rep Winner asked if this will delay the project timeline. Director Hugen responded that the project is scheduled to start in August due to steel and lumber supply delay.

Comm Rep Musial asked how high the bids were that were received. Director Hugen responded that the \$650,000 budgeted project received bids totaling \$990,000. Musial asked if the companies can re-bid next round. Hugen confirmed the companies can be re-bid next round.

# D. <u>Revenue and Expenditure Report, Financial Analysis, and District Wide Operations</u> <u>Statement</u>

Director Hopkins highlighted from the Financial Analysis Report, the property tax revenue is behind due to the extension for residents to pay their property taxes this year. When comparing Q1 to prior years, COVID didn't impact Q1 last year, but there will be an impact in future quarter comparisons. Hopkins also highlighted that there are areas that are seeing signs of recovery. Hockey exceeded spring enrollment numbers and golf is off to a great start being better than last spring. In addition, fitness membership is typically down in March, but this year there was an increase.
