Commissioner Evans stated he feels at this point, spending this amount of money of something that has not been in use very long, and adding on such a large amount to a new project is something that should be put off for a year.

Commissioner Friedman asked if there was a bathroom in the original plans for the TopTracer facility. Director Bechtold said that yes, the initial general scope included a bathroom, but then the project was scaled back to save money.

Executive Director Talsma stated that after the TopTracer facility opened, we realized it was a mistake to leave it out.

Commissioner Dressler asked if the original budgeted amount included a bathroom. Executive Director Talsma stated it did not. Commissioner Dressler also said she does not want to spend that kind of money, but sees the benefit. She then asked how much business Bridges saw at the TopTracer facility after opening. Director Bechtold responded that we had 198 hours of rental without advertising.

Director Bechtold added that the number one question throughout December was where the bathroom is.

Commissioner Chhatwani stated that the facility is designed for all ages. A bathroom would be necessary for a parent with a child, as well as older residents.

Commissioner McGinn noted that other areas will be using the bathroom as well, including the patio and gazebo area.

Commissioner Friedman asked to confirm that the bathrooms were gender neutral and ADA compliant. Director Hugen replied yes.

#### EXECUTIVE DIRECTOR'S REPORT

February 2022

#### PARKS DIVISION REPORT

#### **ADMINISTRATION**

Bids were received for parking lot crack fill and sealcoat, Seascape concrete work, as well as the proposals for Hoffman Playground. The request for qualifications for architectural services is set to go out February 16, 2022 for the renovations at Willow Recreation Center. Once this process is complete staff will develop a timetable for the renovation at WRC. Staff was able to attend the IPRA/IAPD Conference and attended many great sessions. Custodial supplies proposals were received and orders placed for all facilities.

We are pleased to welcome Bryan Strampel as the district new Forestry and Landscape Manager. Bryan will come to us from Northbrook Park district where he served as a Horticulture Specialist. Bryan has twelve years' experience in forestry and landscape work and we are extremely excited about what he will bring to the district.

#### **BRIDGES DRIVING RANGE ENHANCEMENT**

With the cracking of the drywall mudd due to the constant moisture changes and sway effect of the bulding the parks construction team seamed all dryway with 1x6 boards. The storage closet had a ceiling and heater installed to make sure all the IT, fire panels and other equipment can be in a temperature-controlled environment. New bay number signs were built and installed over the walkway to identify each bay. Currently the sound system and interior building signage are being installed.



#### **VOGELEI HOUSE (NWSRA)**

Staff completed walk throughs with NWSRA and Integrity (contractor) to layout the building electrical and IT plan. NWSRA also had a meeting with their interior designer to develop a plan for furniture. The contractor has continued to work on interior items and outside when weather allows. We have a construction progress meeting schedule for February 16, 2022.



#### **PARKS DEPARTMENT**

Other items completed by the parks team in January listed below:

- Replaced thermostat and wiring on unit at TC in the utilities room.
- Replaced fan motor on heater in the generator room at TC.
- Turn off Bubblers at North Ridge, North Twin and South Twin.
- HVAC and electrical repairs at multiple facilities.
- Install new LED light fixture for TC hot tub.
- Started the install of hand dryers in the lockers rooms for the ice rinks.

- Installed new basketball hoop motor at TC.
- Installed two new basketball switches at The Club.
- Cattails at Black Bear Park were cut down to ice level and removed. In the spring an aquatic herbicide will be applied to control spread of cattails.
- Custodial supplies inventoried and organized.
- Parks chemical storage room was cleaned, shelving installed and organized.
- Snow removal at facilities, parks and school sidewalks.
- Constructed and installed park ID sign at Birch Park.
- Installed No Fishing/Ice Skating Only sign at appropriate ponds and No Skating/Ice Fishing Only at appropriate ponds.
- Finished the install of flooring and cabinets at TC, except for room 107 which will be completed during spring break.
- Custodial maintenance at all facilities.
- Vehicle safety and emission test completed.
- Vehicle checks and repairs.
- Mower cleaning and winter repairs.
- Vehicle preparation for snow plowing and snow blower maintenance.

#### RECREATION DIVISION REPORT



Programs for All update – seven children were enrolled into winter figure skating and one child was enrolled in indoor winter soccer.

Steve Dietz, the current Willow Facility Manager, was promoted to the new Superintendent of Recreation position. With the Willow position now vacant, the priority effort will be to replace the Aquatic Manager followed by the Willow Facility Manager.

Little Stars Child Care has 37 children enrolled; last December there were 18 children. The third LSC classroom opened on January 10. Two part-time teachers have transitioned to their full-time teacher roles within the LSC, Charlotte Chiero and Remya Nedumpurath. A third LSC full-time teacher will begin on February 14. Having three full-time teachers provides one consistent teacher in each classroom everyday alongside a half-day part-time preschool teacher in the morning and afternoon.

LSC open houses will be held on February 12 and March 12 to boost enrollment in each classroom.

WRC preschool is still looking for a director-qualified part-time teacher.

The preschool program was awarded \$3,960 and \$22,440 from the Child Care Workforce Grant. These funds are used for teacher bonuses as the grant was created to support teachers returning to the workforce during COVID.

Winter Early Childhood enrichment: Five classes are running at TC with 38 students and WRC has four classes running with 28 students. These enrichment classes are offered immediately after preschool dismisal giving students an extended day in their classroom. Enrichment was not offered last year for comparisons due to COVID and not mixing students.

#### **Member Services/Sales**

• The Club experienced another set-back in January with Cook County announcing they were mandating proof of vaccine for facility use on January 3. This made an impact on our new member enrollments as well as cancellation numbers. We finished the month

- with 110 new enrollments, and unfortunately 128 (plus approximately 15 more that cancelled in December as soon as we put out the communication) cancellations. Almost all of the cancellations indicated it was because of the vax mandate.
- We had about 150 members take advantage of the no charge hold option we offered to those who were unable or unwilling to provide proof of vaccination. These members will be removed from hold status when the mandate lifts.
- We are looking forward and planning for March to be an exciting month as we believe all mandates will be lifted and expect members on hold to return, as well as those who do not want to work out with masks to return as well.
- We had 1,483 unique visits in January. Meaning, approx. 70% of members are visiting/using the facility at least once a month. This is not a bad number given the restrictions, but should definitely be higher for a fitness facility in January.

#### **Operations and Fitness Departments:**

- We needed to pull back on a lot of our planned rentals and activities in January, because of the vax mandate. For example, we would typically run adult volleyball tournaments throughout the winter months, but because this would require vax proof from the participants, these organizations cancelled with us and went elsewhere. We also had to cancel our Parent's Night Out event because we serve a pizza dinner as part of that event, and 2 birthday parties and 2 overnight lock-ins cancelled with us as well.
- Looking past this somewhat disappointing month, The Club staff are looking forward to adding in some great programming beginning in March. We are going to offer a teen weight training intro class, personal training for golfers, teen yoga and parent-baby yoga classes, and an early childhood art class.
- We have also gotten word that some of the corporate park companies will begin to bring back staff mid-March. With this, we will likely bring back one or two noon time group fitness classes.

- Implemented the Cook County Test or Vaccination requirement for all employees. All departments worked diligently to get the vaccination status of all active employees. Getting this information was a big lift and everyone involved did a great job! The vaccination cards were entered into BS&A for easy access and reporting.
- Out of approximately 350 active employees, nine employees opted to test instead of vaccination. Of those nine, two ended up getting vaccinated. Two additional

- employees opted to quit instead of submitting to testing. All full-time and part-time childcare employees were already vaccinated per policy.
- Managed a few issues regarding our vision insurance changing administrators over to Blue Cross/Blue Shield. These issues caused some confusion with incorrect letters being sent to staff but they did not interrupt service.
- Attended multiple PDMRA trainings including the Safety Coordinator update.
- Began updating our hiring process and updating our orientation. We started moving our new hire packets over to PandaDoc, which will be completed in February. We also collaborated with C&M on a PowerPoint titled "Introduction to Hoffman Estates Park District".
- Assisted legal counsel on a confidential personnel issue.

Keith has summarized his takeaways from the sessions he attended at the IAPD/IPRA Conference last week, and they have been attached for your information. Craig has responded to some of Keith's questions in red.

#### Friday 8:30 110 Legal/Legislative Part I -

<u>Best new legislation</u> - Parks can apply for DCEO tourism grants - will this be available to offset our hosting hockey tournaments? This is a grant that provides for capital improvements that increase tourism. Hockey would be our main area but not at a level that would probably get this grant.

Best financial news - Property Tax refund recapture (allows parks to recover refunds over and above tax cap increase) This is automatic and yes we will receive these prior period refunds now. Long shot - IDOT must allocate bike path spending along with state route road improvements - be interesting to see if we could finagle funding for the pass through easement between Higgins & Golf that runs alongside the east fence of Triphahn Center Yes, we discussed but I would think the these program would be for paths alongside state roads and not for pass throughs. (CE 2104)

#### Friday 10:00 207 Repurposed and Unexpected Parks -

<u>Best message</u> - As shopping malls and corporate campuses are being abandoned - look for opportunities to carve out space to repurpose as green space, even top level of parking decks can be used as park space. We do watch for opportunities to do this in redevelopments like Bell Works we have proposed some ideas.

Anything goes idea - could a section of Poplar Creek (the waterway, not the golf course) be reclaimed as a usable (narrow) kayak/canoe access way? Village and Forest Preserve might have an interest. Not sure of safety of passages under roadways/tollway. (CE 2207) I don't think there is a waterway at Bridges large enough for that purpose. Most of the flow through are through culverts, the same as our parks.

#### Friday 1:00 1007 Democratizing Parks Through Arts/Culture -

<u>Best Message</u> - CPD hires artists to run creative projects in the community, possibly resulting in a a permanent installation like a mural, sculpture. Partner with arts foundation like The Backyard Experience (local - my suggestion). We can check with local high schools.

<u>Interesting Concept</u> - "Queering the Parks" mainly a youth program, try to get youth leaders to arrange/design events. Started out slow, gains momentum, had success with an outdoor expo with vendor support, 1000 attended (3 years into program). Would suggest partnership with Schaumburg Parks and STDLibrary to draw from a bigger demographic. The term "Queer" is very inclusive, we can go outside the gender definition and include disabled. Made contact with an Elgin Parks gentleman who runs pride events in Elgin, I gave him my card and asked him to send his contact info. (CE 2309)

#### Friday 3:45 137 Read Beyond the Beaten Path Parks/Libraries -

<u>Best Message</u> - combine summer camp with reading theme with STDLibrary or Palatine Lib. Reward for completion could be family night at pool.

<u>Question</u> - Do we collaborate with a library on camps or any reading programs (or seniors)? We have done some small programs with the Willow site PLD.

Good idea - "Story walks" seem like a natural collaboration. Groups walk through a park with a book divided into pages and hung on signs throughout the park. Popular during COVID. Parent/child event. Library will do in any language, they provide the books/split funding.Also ask Rotary for \$\$ help.

Other good Idea - "Little Free Library" in the park, kept stocked by library volunteers. I saw these in Seattle neighborhoods. (CE???? missed it) There are some of these in Hoffman, most located in people's yards. It is a book exchange type concept.

#### Saturday 10:30 203 Celebrating Nature Preserves -

<u>Legal Definition</u> - Nature Preserves dedicated to biodiversity, apply to state for designation, subject to use restriction. A halfway designation (waterway or land reserves) allows more human use.

Challenge - Reestablishing biodiversity of prairies in IL is time and resource consuming. Cook County Forest Preserves replanted many acres with native Indiangrass (see reddish brown tall grass in Ned Brown and A Janura forest preserves), it is a great start, but lacks the biodiversity of the original prairie. To reestablish biodiversity, a variety of other plants need to be introduced, which involves volunteers collecting seeds and transporting/planting them in the restoration area. Some plants are very rare, therefore expensive. The county used indiangrass because it is cheap, easy to sow and plentiful. Great start, and a good habitat for animals, but the next step takes time (10 years minimum) and lots of volunteers (fortunately, projects like this tend to attract people over time willing to pitch in). (CE3106) We did create the biodiversity swale at Vogelei and continue to do some of this type of work with our natural shoreline management program.

#### Saturday 12:30 121 Recreational Property Liability Status -

<u>Best idea</u> - must have property inspection program, pavement, playgrounds, buildings. Areas with more usage = more frequent inspections <u>Yes</u>, we do park and playground inspections regularly.

<u>Important concept</u> - Tort Immunity Act requires willful and wanton conduct to prove liability of an agency. Tough to prove but it can be done. Yes very difficult but always can be challenged. Good PDRMA attorneys help with this.

<u>Caution</u> - are there hills in HEParks used for sledding other than in designated areas? If kids are sledding in a dangerous area, and we know about it (sledding leaves a lot of evidence) and agency does not post prohibited activity signs, we could be liable for injury. The only place this happened was individuals goin g the wrong side at Seascape, where we put fencing and signage. <u>Similarly</u> - "Stay on Trail" signs needed for natural areas. (CE 3203)

#### Saturday 2:00 124 Not in my Backyard -

<u>Best idea</u> - Even though Supreme Court stopped fed mandate on OSHA vax rules for employees, there is nothing stopping individual agencies from implementing vax requirements on staff. Yes, we have the mandated vax policy for FT and that or testing for PT.

Good question - retention of security cam data (90 days is recommended but can be shorter) must be written in policy and adhered to, with limited access time to review if there is an incident. FOIA-able Yes we have a reoccurring authorization from the Secretary of State Local Records Commission for the continuous disposal of video every 30 days. (CE 3304)
