#### **EXECUTIVE DIRECTOR'S REPORT**

October 2022

#### PARKS DIVISION REPORT

#### **ADMINISTRATION**

Luigi Cutolo was hired as the district GIS & Park Administrator. Luigi is a recent graduate of DePaul University and was working for the Village of Arlington Heights prior to accepting the district's position.

Parking lot repairs were completed on September 21 at Victoria Park, Huntington Park and Bridges of Poplar Creek Driving Range.

Staff attended the NRPA conference and was able to attend many educational classes. Some highlights of the education included information on applying for federal grants, park design concepts, accessible play, top trends in park and recreation and ADA compliance.

The OSLAD Grant for Pine Park was submitted on September 29.

ForeverLawn installed the new driving range tee at Bridges of Poplar Creek on October 5.



#### PARK / PLAYGROUND RENOVATIONS

Poplar Park and Hoffman Park have been completed and are open to the public. Huntington Park has experienced another delay in the playground equipment. ParKreation has informed us that the equipment is now set to arrive in late November. Staff is working with the installer to see what options we have for a December install.



#### **PARKS DEPARTMENT**

- Detention ponds treated for algae growth.
- Sign beds weeded and trimmed.
- Inspections and repairs to district fleet, mowers and equipment.
- Vehicle checks and repairs.
- Mower and parks equipment checks and repairs.
- Playground checks and cleanups.
- Sod installed at Bridges Driving Range around new tee.
- Finished tree pruning at Poplar in advance of park opening.

- Pruned back trees around Victoria soccer fields to improve light and air movement on field.
- Cleaned all landscape beds at Hoffman for park opening.
- Installed mulch at Village of Hoffman Estates Police Station.
- Completed end of season landscaping at Seascape.
- Landscaping of park ID signs (93 of them).
- Submitted all Burn Permit applications to state; once approved, will submit to the Village.
- Completed stone work around storm drain and capped pipe at Top Tracer.
- Landscaping at Tropicana Park and Field Park.
- Complete refinish of TC spa. Ground down old epoxy, re-grouted tile, installed new drain grate and installed new depth markers and re-painted epoxy with sand grit.
- Ran new wires to north wall lights at The Club.
- Ran new wiring from power distribution panel to gate latch at Bo's run.
- Installed new volute on activity pool chlorination pump.
- Drained down Seascape and completed end of year maintenance.
- Remounted lift station pump and fixed tangled float wires at Seascape.
- Installed new inducer motor on RTU 5 ice rink dehumidification unit.
- Installed new timer on men's steam room boiler.
- Shut down splash pads for the season.
- Repaired and replaced acid feed tube to activity pool.
- Replaced vent damper handles on RTU at the club. Handles broke causing vents to close, sending air downstream to the last vent.
- Grease trap cleaned by A&P Grease Trappers for TC ELC kitchen.
- Multiple lights and ballast changed at TC.
- Changed 32 light bulbs in Wolves offices and locker rooms.
- HOFFMAN installed turf ADA walkway from entrance to transfer deck on new playground, installed 4 truckloads of playground mulch (320 yards) and installed new park I.D. sign.
- Installed new artificial turf over mulch bed areas at Poplar Park.
- Installed new park ID signs at Westbury, Victoria, Pine and Hoffman Parks.
- Repaired zip line cable at South Ridge Park.
- Graffiti removal at Fairview and Tropicana Park.
- Painted building trim at Seascape.

#### RECOMMENDATION

Staff recommends that the Buildings & Grounds Committee forward the Parks, Planning and Maintenance October Board Report to be included in the October Executive Director's Report for Board approval.

#### **Member Services/Sales**

- The Club team enrolled 93 new members in September. This is an average number of new enrollments for September, on par with the September average for the past few years.
- Visit numbers were steady in September with a total of 13,005 check-ins for the month. This is down from August (approx. 15,000) and a reflection of the student members returning to school as well as the first couple weeks of September being very slow due to all of the back-to-school activities.
- We had 1,411 unique visits in September, meaning approximately 62% of members visited/used the facility at least once a month. This is low for our average (typically over 75%) but another reflection of the lower attendance all around in the facility in the first half of September.

#### **Operations and Fitness Departments:**

- We kicked off September with several fun member retention activities to get members reengaged as they begin to come back inside for workouts:
  - O AB-tastic challenge fitness department created a calendar of daily abdominal workouts for members to complete; C&M supported this challenge with daily posts on Instagram and Facebook (example below) where a video of each day's exercise was posted. Members turned in completed calendars at the end of month for a drawing for a backpack.




• Eraser Raffle – guess the number of erasers in the jar (these guessing games are always a huge hit!)





• Average retail prices for electricity are released by the Energy Information Administration with a two-month lag. The electric contract the District entered in December 2020 has resulted in \$42,811 in savings through July 2021.



• The Illinois Commerce Commission provides current and historical rates per dekatherm for natural gas. Using the per dekatherm cost for Nicor, the District saved \$22,791 from the partial contract entered November 2021 through October 2022. The District has entered into an 18-month contract for \$6.58 per dekatherm. This puts the contracted rate well below the market rate for ten of the past twelve months with



an overall projected savings of \$26,000 annually. By choosing an 18-month contract, the District will be in a position to take advantage of summer rates as the contract nears completion or extend the contract at a negotiated new rate should the market return to prices from prior years.

The dates listed are unofficial at the time this calendar went to press, however, once the State Board of Elections publishes its Campaign and Finance Calendar, a complete list of all election dates will be available under the Legal section of the IAPD website at ILparks.org, All candidates and voters are encouraged to seek the appropriate legal advice concerning their rights and obligations.

For purposes of this calendar, "election authority" means the County Clerk or the Board of Election Commissioners. "Local election official" means the clerk or secretary of a unit of local government or a school district. "Business day" means any day in which the office of an election authority, local election official or the State Board of Elections is open to the public for a minimum of seven hours. (10 ILCS 5/1-3)

# FILING AND REGISTRATION DATES

(a) Filing and registration dates are fixed by the Election Code. The dates shall conform to those expressed in statute unless they fall on a date which is not a business day as defined above. In such case(s), the period shall extend through the first business day next following the day otherwise fixed as the first or last date. (10 ILCS 5/1-6(a))

(b) If the first or last day of any action required or allowed by the Election Code falls on a State Holiday, Saturday, or a Sunday, the period shall extend through the first business day following the day otherwise fixed as the first or last day for filing or the close of registration, irrespective of whether any election authority or local

election official conducts business on the State Holiday, Saturday, or Sunday. (10 ILCS 5/1-6(a))

(c) For the section of the Election Code upon which this calendar is based, "State Holiday" means New Year's Day, Dr. Martin Luther King Jr.'s Birthday, Lincoln's Birthday, President's Day, Casimir Pulaski's Birthday, Good Friday, Memorial Day, Juneteenth National Freedom Day, Independence Day, Labor Day, Columbus Day, Veterans' Day, Thanksgiving Day, Christmas Day, and any other day declared by the President of the United States or the Governor of Illinois to be a day during which the agencies of the State of Illinois that are ordinarily open to do business with the public shall be closed for business. (10 ILCS 5/1-6(b)

(d) To receive specific signature requirements for any particular office, candidates should contact the election authority or local election official who is responsible for receiving the filing of the petition for nomination and/or election to office.



# BEFORE PROCLAMATION BY THE ELECTION AUTHORITY

Prior to the canvass, in those jurisdictions where in-precinct counting equipment is utilized, the election authority shall re-tabulate the total number of votes cast in 5% of the precincts within the election jurisdiction, as well as 5% of the voting devices used in early voting as selected on a random basis by the State Board of Elections. (10 ILCS 5/24A-15, 24B-15, 24C-15)

# AFTER PROCLAMATION CERTIFICATE OF ELECTION

The election authority shall issue a certificate of election to each person declared elected. For political subdivisions which are multicounty, the election authority of the county where the principal office of the political subdivision is located shall make the certificate of election. (10 ILCS 5/22-18)

#### WRITE-IN CANDIDATES

Each successful write-in candidate elected shall file the following documents with the proper election authority or the State Board of Elections prior to taking office: (1) a Loyalty Oath (optional), (2) a Statement of Candidacy, and (3) a receipt for filing a Statement of Economic Interest. (10 ILCS 5/22-7)

#### **DISCOVERY RECOUNT**

Within five days after the last day for the proclamation of the results, petitions for discovery recount may be filed by any candidate who came within 5% of the winning candidate. Such petition is filed with the appropriate election authority. (10 ILCS 5/22-9.1)

# **ELECTION CONTEST**

In general, the circuit court shall hear election contests. Individuals should refer to the particular statute which applies to their unit of government. (10 ILCS 5/23-4, 23-5)
