Background

The Property Tax Extension Limitation Law applies to non-home rule taxing districts like the Park District. This law limits the total amount levied to the lesser of the inflation from the prior year or 5%. Inflation is calculated as the change between the consumer price index (CPI) for all goods and services from December to December. With the unprecedented inflation over the past two years, the CPI increase for the prior year was 7.0%.

The Truth in Taxation Law requires any taxing district proposing a levy of more than 5% to publish a notice in the local newspaper and hold a public hearing.

Implications

To capture/recapture property new to the jurisdiction, the District routinely levies for an amount greater than the CPI. This philosophy has allowed the District to maintain and improve assets without requesting additional funding from the taxpayers via referendum. It has also helped to offset areas where the CPI is not reflective of the increases in goods or services for the District. Along with routine new additions to the tax roll, the Barrington/Higgins Road Tax Increment Finance district ended, allowing the District to add that property back to the levy.

With the limitation at 5% for the 2022 levy year, in order to capture the TIF property and any other new growth, the District will be requesting a capped funds levy of \$7,719,000. This excludes the Debt Service and Special Recreation Fund's levies. This portion of the levy which is subject to the truth in taxation hearing is increasing by 8.553% over the prior year's extended capped fund's levy. The total requested levy for 2022 is \$11,285,150, an overall increase of 5.716%. Once the Assessor has completed the property valuations, the county will automatically reduce the levy, so the addition to existing properties is not greater than the limitation.

Recommendation

The purpose of this notice and meeting is to allow the public an opportunity to provide input. Adoption of the final levy will occur at the December 20, 2022 board meeting.

The corporate and special purpose property taxes extended for 2021 were \$298,301,057.

The proposed corporate and special purpose property taxes to be levied for 2022 are \$317,208,623. This represents a 6.34% increase over the previous year.

The property taxes extended for debt service and public building commission leases for 2021 were \$32,436,792.

> The estimated property taxes to be levied for debt service and public building commission leases for 2022 are \$32,061,979. This represents a decrease of 1.16% over the previous year.

The total property taxes extended or abated for 2021 were \$330,737,849.

The estimated total property taxes to be levied for 2022 are \$349,270,602. This represents a 5.60% increase over the previous year.

The proposed corporate and special purpose property taxes to be levied for 2022 are \$7,719,000. This represents a 8.553% increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for 2021 were \$3,564,180.

The estimated property taxes to be levied for debt service and public building commission leases for 2022 are \$3,566,150. This represents a 0.055% increase over the previous year.
