**6. New Business:**

A. NWSRA IGA – Conflict of Interest Disclosure and Waiver / M25-025

Comm Rep Wilson made a motion, seconded by Comm Rep Harner to recommend to the full board the approval of the Disclosure, Consent, and Waiver of Conflicts of

Interest Request from Robbins-Schwartz for the Intergovernmental Agreement with NWSRA regarding the continued rental of the Vogelei House.

Executive Director Talsma stated that this is straightforward, and the two organizations have different attorneys within the same firm, so they are agreeing to a waiver of conflict of interest.

**HOFFMAN ESTATES PARK DISTRICT MEMORANDUM NO M26-039**

**Motion:**

Recommend to the full board the approval of the first amendment to the cell tower lease at Cannon Crossings with Global Tower Assets III, LLC to extend the lease for seven additional five-year terms commencing with the end of the current lease of July 31, 2038, to July 31, 2073.

**Background:**

Staff have negotiated with our current tenant of the cell tower at Cannon Crossings to extend their lease for up to seven additional five-year terms starting with the expiration of all current lease options. A copy of the addendum is attached. The original lease was entered into on February 26, 2008, and if all renewals were utilized it would run through 2038. The lease will continue to run annually with a three percent (3%) annual rent escalation. The current monthly lease payment is \$3,223.07.

The tenant will pay the District \$10,000 as a one-time fee (in addition to all future monthly payments) for the extension. Additionally, we will be allowing them an additional three foot by three-foot square (nine square feet total) adjacent to their current structure. They will pay an additional \$50 per month for this (3,273.07). Also, if there is ever a collocation or second provider added to the tower, the district will receive an additional \$200 per month added to the lease value.

The District is also allowing them right of first refusal should we ever be approached by another carrier or cell tower provider, Tenant would be allowed to match any proposal to provide an additional cell tower at Cannon Crossings.

**Rationale:**

Staff have been working for the past two years on this negotiation for an extension, and we are pleased with the final proposal. Our attorney has completely vetted and corrected the Amendment and has approved this final version, as have the tenant's attorney. All other aspects are still governed by the original approved contract. Assuming all extensions are utilized, the new agreement would secure \$4 million dollars of future value funds for the District over the term of the lease.

## THE FIRST AMENDMENT TO LAND LEASE AGREEMENT

This First Amendment to Land Lease Agreement (this "**Amendment**") is made effective as of the latter signature date hereof (the "**Effective Date**") by and between **Hoffman Estates Park District**, an Illinois municipal corporation ("**Landlord**") and **Global Tower Assets III, LLC**, a Delaware limited liability company ("**Tenant**") (Landlord and Tenant being collectively referred to herein as the "**Parties**").

### RECITALS

**WHEREAS**, Landlord owns the real property described on **Exhibit A** attached hereto and by this reference made a part hereof (the "**Parent Parcel**"); and

**WHEREAS**, Landlord and Tenant (or its predecessor-in-interest) entered into that certain Land Lease Agreement dated February 26, 2008 (the "**Lease**"), pursuant to which the Tenant leases a portion of the Parent Parcel and is the beneficiary of certain easements for access and public utilities, all as more particularly described in the Lease (such portion of the Parent Parcel so leased along with such portion of the Parent Parcel so affected, collectively, the "**Leased Premises**"), which Leased Premises are also included in the legal description set forth on **Exhibit A**; and

**WHEREAS**, Landlord and Tenant desire to amend the terms of the Lease to extend the term thereof and to otherwise modify the Lease as expressly provided herein.

**NOW THEREFORE**, in consideration of the foregoing recitals and the mutual covenants set forth herein and other good and valuable consideration, the receipt, adequacy, and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

- One-Time Payment.** Tenant shall pay to Landlord a one-time payment in the amount of **Ten Thousand and No/100 Dollars (\$10,000.00)**, payable within thirty (30) days of the Effective Date and subject to the following conditions precedent: (a) Tenant's receipt of this Amendment executed by Landlord, on or before \_\_\_\_\_; (b) Tenant's confirmation that Landlord's statements as further set forth in this Amendment are true, accurate, and complete, including verification of Landlord's ownership; (c) Tenant's receipt of any documents and other items reasonably requested by Tenant in order to effectuate the transaction and payment contemplated herein; and (d) receipt by Tenant of an original Memorandum (as defined herein) executed by Landlord.
- Lease Term Extended.** Notwithstanding anything to the contrary contained in the Lease or this Amendment, the Parties agree the Lease originally commenced on August 1, 2008 and, without giving effect to the terms of this Amendment but assuming the exercise by Tenant of all remaining renewal options contained in the Lease (each an "**Existing Renewal Term**" and, collectively, the "**Existing Renewal Terms**"), the Lease is otherwise scheduled to expire on July 31, 2038, subject to the Parties' rights to terminate pursuant to the terms of the Lease. In addition to the Existing Renewal Term(s), the Lease is hereby amended to provide Tenant with the option to extend the Lease for each of seven (7) additional five (5) year renewal terms (each a "**New Renewal Term**" and, collectively, the "**New Renewal Terms**"). Notwithstanding anything to the contrary contained in the Lease, all Existing Renewal Terms and New Renewal Terms shall automatically renew unless (a) Tenant notifies Landlord that Tenant elects not to renew the Lease, as amended herein, at least sixty (60) days prior to the commencement of the next Renewal Term (as defined below); (b) Landlord notifies Tenant that Landlord elects not to renew the Lease, as amended herein, upon expiration of all of the remaining Existing Renewal Terms or any successive New Renewal Term thereafter, at least sixty (60) days prior to the commencement of the next New Renewal Term; or (c) Landlord terminates the Lease, as amended and provided for herein. For the avoidance of doubt, Landlord shall not be able to exercise the termination right granted to Landlord pursuant to Section 2(b) until all Existing Renewal Terms have been renewed and expired, and further Landlord is only able to exercise such termination right only prior to the commencement of the first New Renewal Term or any New Renewal Term thereafter in accordance with

the notice requirement listed in Section 2(b) above. Landlord shall be able to terminate the Lease in the event of an uncured default by Tenant in accordance with the terms herein. In the event of a default by Tenant, Landlord shall provide written notice of such default to Tenant. If Tenant fails to cure such default within sixty (60) days of Tenant's receipt of written notice thereof, Landlord may terminate the Lease and pursue any and all legal and equitable remedies available to Landlord in accordance with applicable law, provided, however, if Tenant has diligently commenced to cure a default within sixty (60) days of Tenant's receipt of notice thereof and reasonably requires additional time beyond the sixty (60) day cure period described herein to effect such cure, Tenant shall have such additional time as is necessary (beyond the sixty [60] day cure period) to effect the cure. References in this Amendment to "**Renewal Term**" shall refer, collectively, to the Existing Renewal Term(s) and the New Renewal Term(s). The Landlord hereby agrees to execute and return to Tenant an original Memorandum of Lease in the form and of the substance attached hereto as **Exhibit C** and by this reference made a part hereof (the "**Memorandum**") executed by Landlord, together with any applicable forms needed to record the Memorandum, which forms shall be supplied by Tenant to Landlord. Tenant shall pay all costs required to record the Memorandum. Further, Tenant shall be obligated to pay all transfer taxes (if any) associated with recording the Memorandum.

3. **Additional Ground Space.**

- a. For good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged, effective as of the Effective Date, Landlord hereby (i) leases to Tenant approximately an additional **nine (9) square feet** of land (the "**Expanded Lease Area**"). The Expanded Lease Area is described, depicted and/or designated on **Exhibit B** attached hereto and by this reference made a part hereof. Tenant may use the Expanded Lease Area in the same manner that Tenant is permitted to use the Leased Premises in compliance with the Lease, as amended hereby. On and after the occurrence of the Effective Date, the Expanded Lease Area shall be (and shall be deemed to be for all purposes), without further action of the Parties hereto, part of the Leased Premises and any references to the Leased Premises in the Lease, as amended hereby, shall include (and shall be deemed to include for all purposes) the Expanded Lease Area.
- b. Landlord hereby grants to Tenant, its officers, agents, employees, customers and/or independent contractors the right and privilege to enter upon the Leased Premises, and/or the Expanded Lease Area at any time on or after the Effective Date, to perform or cause to be performed test borings of the soil, environmental audits, sampling, and/or tests or engineering studies (collectively, "**Studies**"). All such Studies shall be conducted at Tenant's sole cost and expense. Tenant shall require any contractors or subcontractors hired to perform the Studies to procure the insurance of the types and amounts and in accordance with terms set forth in Section 9 of the Lease and shall require such contractors and subcontractors to provide Landlord with a certificate of insurance (or evidence of insurance) prior to accessing the Expanded Lease Area. Tenant and American Tower may enter upon the Parent Parcel to conduct a non-invasive survey of the Parent Parcel, Leased Premises and/or the Expanded Lease Area. Any other activity that Tenant may require to be performed on the Parent Parcel shall only be performed after Tenant's receipt of written authorization from Landlord to perform the specified activity, such authorization not to be unreasonably withheld, conditioned or delayed. Further, at any time on and after the Effective Date, Landlord grants to Tenant, its officers, agents, employees, customers and/or independent contractors the right and privilege to enter upon and reasonably use, for purposes of ingress and egress, the portions of the Parent Parcel immediately adjacent to the Leased Premises and Expanded Lease Area for the purposes of accessing, constructing, installing, repairing, maintaining, and/or removing improvements within the Leased Premises and/or Expanded Lease Area. Tenant shall not install any temporary or permanent improvements on any property adjacent to the leased Premises or the Expanded Lease Area unless prior authorization is obtained from Landlord, such

authorization not to be unreasonably withheld, conditioned or delayed. Landlord will not unreasonably interfere with Tenant's use of the Parent Parcel, Leased Premises and/or the Expanded Lease Area, in conducting the activities authorized by this Amendment or other activities that require Landlord's approval as the case may be. In the event any physical disturbance or damage is caused to the Parent Parcel, Leased Premises or the Expanded Lease Area arising out of or resulting from any Studies performed by Tenant, or on behalf of Tenant, in accordance with this Section 3(b), Tenant shall restore, or cause the same to be restored, to its original condition, reasonable wear and tear and casualty excepted.

- c. Effective as of the Effective Date, the total rent payable under the Lease, as amended hereby, shall be increased by a sum of **Fifty Dollars (\$50.00)** per month. As a result of the aforementioned increase and as more fully described in Section 4 below, as of the Effective Date the total rent amount due, including this Fifty Dollar (\$50) per month increase, as of the Effective Date will be an amount equal to **Three Thousand Two Hundred Seventy-Three and 07/100 Dollars (\$3,273.07)** per month. The Parties hereby acknowledge and agree that all applicable increases and escalations to the rent authorized pursuant to the Lease shall continue in full force and effect and shall be applied to the increased rent as provided in this subparagraph.
4. **Rent and Escalation.** The Parties hereby acknowledge and agree that the rent payable from Tenant to Landlord under the Lease is currently **Three Thousand Two Hundred Twenty-Three and 07/100 Dollars (\$3,223.07)** per month (the "**Rent**"). Effective as of the Effective Date, in accordance with Section 3(c) above the Rent will increase by a sum of **Fifty and 00/100 Dollars (\$50.00)** per month for a total rent amount due as of the Effective Date in the amount of **Three Thousand Two Hundred Seventy-Three and 07/100 Dollars (\$3,273.07)** per month. Commencing on August 1, 2026 and on each successive annual anniversary thereof, Rent due under the Lease, as amended herein, shall increase by an amount equal to **three percent (3%)** of the then current Rent. In the event of any overpayment of Rent or Collocation Fee (as defined below) prior to or after the Effective Date, Tenant shall have the right to deduct from any future Rent payments an amount equal to the overpayment amount, after providing prior notice to Landlord of such overpayment. Notwithstanding anything to the contrary contained in the Lease, all Rent and any other payments expressly required to be paid by Tenant to Landlord under the Lease and this Amendment shall be paid to **Hoffman Estates Park District**. The escalations in this Section and Section 3(c) shall be the only escalations to the Rent and any/all rental escalations otherwise contained in the Lease are hereby null and void and are of no further force and effect.
  5. **Revenue Share.**
    - a. Subject to the other applicable terms, provisions, and conditions of this Section, Tenant shall pay Landlord an amount equal to **Two Hundred and 00/100 Dollars (\$200.00)** per month for each sublease, license or other collocation agreement for the use of any portion of the Leased Premises entered into by and between Tenant and any third party (any such party, the "**Additional Collocator**") subsequent to the Effective Date (such amount, the "**Collocation Fee**"). Commencing on the first anniversary of the initial payment of any Collocation Fee, and on each successive annual anniversary thereof, such Collocation Fee shall increase by an amount equal to **three percent (3%)** of the then current Collocation Fee. The Collocation Fee for each Additional Collocator shall start at the dollar amount specified above and increase as described herein.
    - b. The initial payment of the Collocation Fee shall be due within thirty (30) days of actual receipt by Tenant of the first collocation payment paid by the Additional Collocator. In the event a sublease or license with an Additional Collocator expires or terminates, Tenant's obligation to pay the Collocation Fee for such sublease or license shall automatically terminate upon the effective date of such expiration or termination. Notwithstanding anything contained herein to the contrary, Tenant shall have no

obligation to pay to Landlord and Landlord hereby agrees not to demand or request that Tenant pay to Landlord any Collocation Fee in connection with the sublease to or transfer of Tenant's obligations and/or rights under the Lease, as modified by this Amendment, to any subsidiary, parent or affiliate of Tenant.

- c. Landlord hereby acknowledges and agrees that Tenant has the sole and absolute right to enter into, renew, extend, terminate, amend, restate, or otherwise modify (including, without limitation, reducing rent or allowing the early termination of) any future or existing subleases, licenses or collocation agreements for occupancy on Tenant's communications tower, all on such terms as Tenant deems advisable, in Tenant's sole and absolute discretion, subject to the terms and conditions of the Lease and this Amendment, notwithstanding that the same may affect the amounts payable to the Landlord pursuant to Section 5.
  - d. Notwithstanding anything to the contrary contained herein, Landlord hereby acknowledges and agrees that Tenant shall have no obligation to pay and shall not pay to Landlord any Collocation Fee in connection with: (i) any subleases, licenses, or other collocation agreements between Tenant, or Tenant's predecessors-in-interest, as applicable, and any third parties, or such third parties' predecessors or successors-in-interest, as applicable, entered into prior to the Effective Date (any such agreements, the "**Existing Agreements**"); (ii) any amendments, modifications, extensions, renewals, and/or restatements to and/or of the Existing Agreements entered into prior to the Effective Date or which may be entered into on or after the Effective Date; (iii) any subleases, licenses, or collocation agreements entered into by and between Tenant and any Additional Collocators for public emergency and/or safety system purposes if such agreement is required or ordered by any governmental authority having jurisdiction at or over the Leased Premises; or (iv) any subleases, licenses or other collocation agreements entered into by and between Tenant and any Additional Collocators if the Landlord has entered into any agreements with such Additional Collocators to accommodate such Additional Collocators' facilities outside of the Leased Premises and such Additional Collocators pay any amounts (whether characterized as rent, additional rent, use, occupancy or other types of fees, or any other types of monetary consideration) to Landlord for such use.
  - e. In connection with Tenant's payment of each monthly Collocation Fee (if any) to Landlord, Tenant will provide Landlord with an accompanying calculation sheet identifying the number of Additional Collocators using a portion(s) of the Leased Premises and any amounts paid by Tenant to Landlord in connection therewith. Landlord shall be permitted to request, no more than once per twelve (12) calendar month period, an annual reconciliation of any and all amounts collected by Tenant from any applicable Additional Collocator together with any payments owed by Tenant to Landlord and actually paid by Tenant to Landlord.
6. **Limited Right of First Refusal.** Notwithstanding anything to the contrary contained herein, this paragraph shall not apply to any fee simple sale of the Parent Parcel from Landlord to any prospective purchaser that is not a person or entity directly or indirectly engaged in the business of owning, acquiring, operating, managing, or leasing wireless telecommunications infrastructure (any such person or entity, a "**Third Party Competitor**"). To the extent permitted by law, if Landlord receives an offer or desires to offer to: (i) sell or convey any interest (including, but not limited to, leaseholds or easements) in the Parent Parcel of which the Leased Premises is a part of to a Third Party Competitor or (ii) assign all or any portion of Landlord's interest in the Lease, as modified by this Amendment, to a Third Party Competitor (any such offer, the "**Offer**"), Tenant shall have the right of first refusal to purchase the real property or other interest being offered by Landlord in connection with the Offer on the same terms and conditions. If Tenant elects, in its sole and absolute discretion, to exercise its right of first refusal as provided herein, Tenant must provide Landlord with notice of its election not later than forty-five (45) days after Tenant receives written notice

from Landlord of the Offer. If Tenant elects not to exercise Tenant's right of first refusal with respect to an Offer as provided herein, Landlord may complete the transaction contemplated in the Offer with the Third Party Competitor on the stated terms and price but with the express condition that such sale is made subject to the terms of the Lease, as modified by this Amendment. Landlord hereby acknowledges and agrees that any sale or conveyance by Landlord in violation of this Section is and shall be deemed to be null and void and of no force and effect. The terms, provisions, and conditions of this Section shall survive the execution and delivery of this Amendment.

7. **Notices.** The Parties acknowledge and agree that Section 23 of the Lease is hereby deleted in its entirety and is of no further force and effect. From and after the Effective Date the notice address and requirements of the Lease, as modified by this Amendment, shall be controlled by this Section of this Amendment. All notices must be in writing and shall be valid upon receipt when delivered by hand, by nationally recognized courier service, or by First Class United States Mail, certified, return receipt requested to the addresses set forth herein: to Landlord at: Hoffman Estates Park District, Attn.: Executive Director, 1685 W Higgins Rd, Hoffman Estates, IL 60619, with a copy to: Attn.: Steven Adams, Robbins Schwartz, 190 S. LaSalle St. Suite 2550, Chicago, IL 60603; to Tenant at: Attn.: Land Management 10 Presidential Way, Woburn, MA 01801, with copy to: Attn.: Legal Dept., 116 Huntington Avenue, Boston, MA 02116. Any of the Parties, by thirty (30) days prior written notice to the others in the manner provided herein, may designate one or more different notice addresses from those set forth above. Refusal to accept delivery of any notice or the inability to deliver any notice because of a changed address for which no notice was given as required herein, shall be deemed to be receipt of any such notice.
8. **Counterparts.** This Amendment may be executed in several counterparts, each of which when so executed and delivered, shall be deemed an original and all of which, when taken together, shall constitute one and the same instrument, even though all Parties are not signatories to the original or the same counterpart. Furthermore, the Parties may execute and deliver this Amendment by electronic means such as .pdf or similar format. **Motion:**

Staff recommends approval of the resolution R26-004 authorizing the establishment and management of bank and investment accounts and the designation of authorized signers.

**Background:**

The District maintains multiple bank and investment accounts to support its operations, including payroll, operating funds, capital projects, and other financial activities. From time to time, it is necessary to open or close accounts or update authorized signers due to staffing changes or operational needs.

These changes can require separate Board resolutions or additional documentation requested by financial institutions, which may delay administrative processes.

**Rationale:**

Staff created a new resolution R26-004 to authorize the Executive Director together with either the Deputy Director or the Director of Finance to establish, modify, and close bank and investment accounts. It also designates authorized signers by either the Executive Director or both the Deputy Director and the Director of Finance to update authorized signers as needed for efficient operations.

The resolution also establishes that the District will maintain no fewer than two authorized signers on all accounts to support appropriate internal control. This requirement does not mandate two signatures on every transaction unless otherwise required by District policy or banking controls.

This approach provides administrative flexibility to respond to operational needs in a timely manner. It eliminates the need for repeated Board resolutions for routine banking changes. It strengthens internal controls through the requirement for multiple authorized signers.

There is no direct financial impact. This resolution supports efficient cash management and administrative processes.

The Executive Director, together with either the Deputy Director or Director of Finance is hereby authorized to establish, open, modify, and close bank accounts, depository accounts, and investment accounts in the name of the District at qualified financial institutions, in accordance with applicable Illinois statutes and District policies.

**Section 2. Designation of Authorized Signers**

The Executive Director or both the Deputy Director and Director of Finance is authorized to designate and update authorized signers on District accounts, including the addition or removal of employees or officers, as necessary for operational efficiency and internal control.

**Section 3. Minimum Authorized Signers Requirement**

The District shall maintain no fewer than two authorized signers on all depository and investment accounts. This requirement ensures appropriate internal control and continuity of operations.

This provision shall not be construed to require two signatures or approvals for each individual transaction unless otherwise required by District policy, banking controls, or specific contractual obligations.

Recommend to the full board the approval of Resolution R26-002 adopting a restated Governmental 457(b) Deferred Compensation Plan.

**Background:**

The District previously adopted a 457(b) Deferred Compensation Plan effective June 30, 2011. Since that time, federal retirement legislation, including the SECURE Act and SECURE 2.0 Act, has amended various provisions applicable to governmental plans.

Rather than layering amendments onto the 2011 document, staff recommends adoption of a fully restated plan document to ensure clarity, compliance, and modernization of plan features.

**Rationale:**

The following items have changed since the original plan was adopted in 2011:

- Authorization of Roth (after-tax) 457(b) contributions
- Elimination of outdated election timing restrictions
- Updates to required minimum distribution provisions
- Expanded rollover authority, including Roth rollover amounts where permitted
- Authorization of multiple plan providers (ex., Nationwide and MissionSquare)
- Optional disaster and other participant-friendly distribution features
- Express inclusion of part-time employees

There is no direct employer contribution requirement associated with these amendments. Administrative costs, if any, are expected to be minimal and absorbed within existing plan administration arrangements.

Staff recommends adoption of the restated plan to ensure compliance with federal law and to enhance retirement planning flexibility for employees.

## RESOLUTION R26-002

### A RESOLUTION ADOPTING A RESTATED GOVERNMENTAL 457(b) DEFERRED COMPENSATION PLAN FOR THE HOFFMAN ESTATES PARK DISTRICT

WHEREAS, the Hoffman Estates Park District (the “District”) is an Illinois park district organized and operating pursuant to the Illinois Park District Code (70 ILCS 1205/1-1 et seq.); and

WHEREAS, the District previously adopted a governmental 457(b) Deferred Compensation Plan originally effective June 30, 2011; and

WHEREAS, federal legislation, including the Setting Every Community Up for Retirement Enhancement Act of 2019 (“SECURE Act”) and the SECURE 2.0 Act of 2022, amended provisions applicable to governmental retirement plans; and

WHEREAS, the District desires to adopt a **restated governmental 457(b) Deferred Compensation Plan** to ensure compliance with applicable federal law and to modernize certain plan features; and

WHEREAS, the District further desires to authorize after-tax (Roth-style) contributions, expanded rollover provisions, multiple administrative service providers, and other plan enhancements consistent with applicable law.

### NOW, THEREFORE, BE IT RESOLVED

by the Board of Commissioners of the Hoffman Estates Park District, Cook County, Illinois, as follows:

1. The District hereby adopts a **restated Governmental 457(b) Deferred Compensation Plan**, effective March 24, 2026, to comply with the Internal Revenue Code, the SECURE Act, the SECURE 2.0 Act, and applicable Treasury regulations.
2. The restated Plan shall:
  - Permit both pre-tax and after-tax (Roth-style) elective deferrals;
  - Update required minimum distribution provisions to reflect current law;
  - Eliminate first-of-the-month election timing restrictions;
  - Permit participation by part-time employees as determined by District policy;

- Authorize acceptance of rollover contributions from other governmental 457(b) plans, 401(k) plans, 403(b) plans, and qualified governmental pension plans, including designated Roth amounts where permitted by law;
  - Permit qualified disaster recovery distributions and other optional distribution features allowed under applicable law;
  - Authorize the use of multiple administrative service providers, including Nationwide Retirement Solutions, Inc. and MissionSquare Retirement.
3. All prior resolutions or provisions inconsistent with the restated Plan are hereby superseded.
  4. The Executive Director and Director of Administrative Services are authorized and directed to execute all plan documents, participation agreements, provider agreements, and amendments necessary to implement the restated Plan.

**Motion:**

Recommend to the full board the approval to purchase a SoloRider ADA Golf Cart for the total of \$18,375 using contingency ADA funds.

**Background:**

In 2013, the District purchased an ADA-accessible golf cart. This cart is utilized throughout the season to provide transportation and accessibility accommodations for patrons requiring ADA support. The District is also required to provide reasonable accommodation and maintain an accessible cart available upon request.

The current ADA cart has exceeded its useful life and is no longer operational. Staff has contacted the manufacturer to explore repair options; however, replacement parts are no longer available, making it impossible to restore the cart to working condition.

**Rationale:**

The board has approved \$50,000 in contingency ADA funds as part of the 2026 overall budget.

Staff has reached out to SoloRider and obtained a quote for a replacement ADA-accessible golf cart. Staff also contacted three major golf cart manufacturers E-Z-GO, Club Car, and Yamaha and confirmed that none currently manufacture ADA-specific golf carts comparable to the District's needs.

SoloRider provided a quote for their latest 35R model, which includes an updated controller and three lithium batteries. This model is similar to the District's previous cart but offers improved power and efficiency. With the addition of a third battery, users can achieve up to three full rounds of golf on a single charge. The 35R model is currently available in two color options: white or green. The quote did provide several accessories enhancements. But staff is recommending only to add on the arm rest for the cart. The current estimated lead time for delivery is 8–10 weeks.

**Motion**

Recommend to the full Board the approval of the Balanced Scorecard for the 1st quarter of 2026.

**Background**

The purpose of the Balanced Scorecard is to provide a snapshot of key performance indicators at a specific point in time, along with an annual comparison. This approach enables the District to assess trends and better understand the direction of its performance across a broad range of areas.

**Rationale**

The Balanced Scorecard offers a high-level view of the District’s progress in relation to its mission, values, and strategic goals. Rather than focusing on detailed budget analysis or financial forecasting, it emphasizes year-over-year comparisons for the same reporting period.

More detailed evaluations of participation trends and financial performance are addressed separately through the monthly Recreation Committee participation reports and the financial statements presented in the A&F Committee reports. The Balanced Scorecard, by contrast, focuses on year-to-date results and compares them to the same period in the previous year to highlight overall direction and performance trends.

The following points outline notable trends and variances relative to the prior year:

***Athletics:*** We saw an increase of 305 youth athletic participants in Q1 2026, with the primary drivers being gymnastics, youth basketball, Learn to Play Soccer, and the addition of a new Futsal program. The growth reflects strong community demand, successful program offerings, and continued momentum in non-traditional youth sports participation.

***Seascape Memberships:*** Memberships at Seascape experienced a strong increase of 218 passes for Q1, driven by successful preseason sales. This year, the preseason sale was extended into the first quarter, which further boosted Q1 sales results. The Marketing team did an excellent job

promoting the campaign through digital advertising and targeted outreach to last year's pass holders, helping generate early momentum and significantly stronger advance sales.

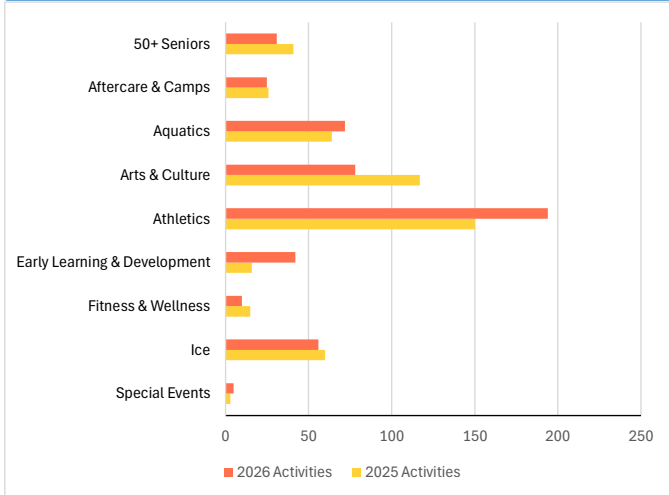
***The Club Memberships & Visits:*** The Club experienced strong momentum in Q1 as increased memberships translated into higher facility usage. Total visits were up 3,933 compared with Q1 2025, driven not only by membership growth, but also by recent facility enhancements and stronger member engagement initiatives. The increase in visits reflects strong participation levels, enhanced member experience, and the positive impact of continued membership growth.

***Grants Land Donations & Advertising:*** The District benefited from an exceptionally strong Q1 2025 in grant and land donation revenue, highlighted by the TC Playground grant and the Bell Works land donation. While no similar grant or donation revenue was recognized in the first quarter of 2026, the District expects additional grant revenue to be received later this year.

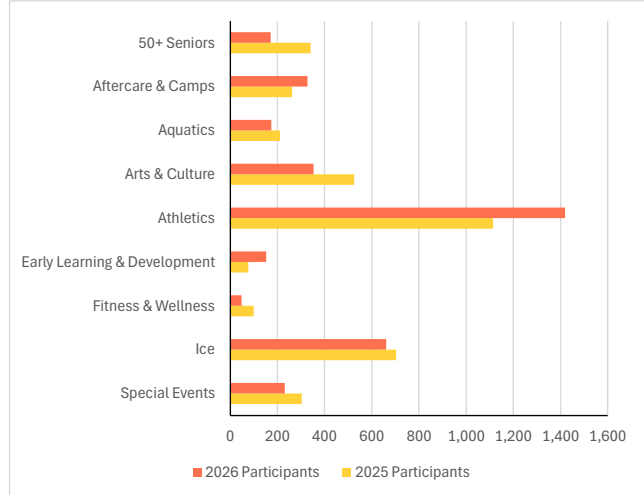


## Balanced Scorecard 2026 Quarter 1 vs Prior Year

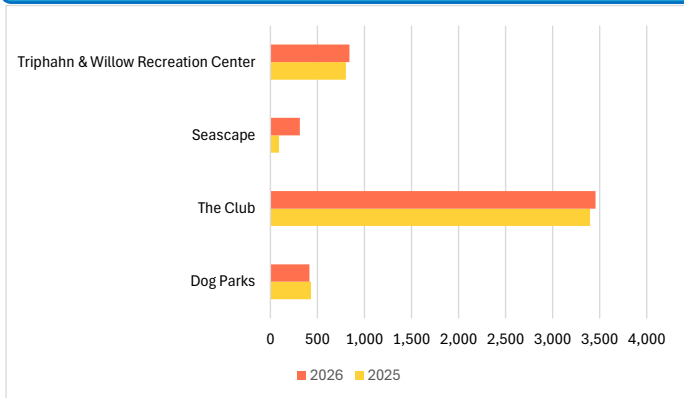

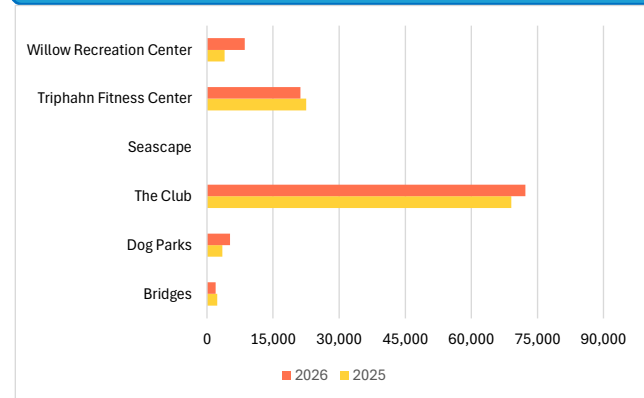

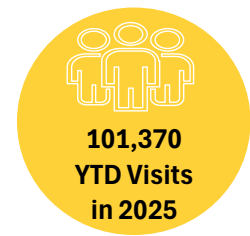

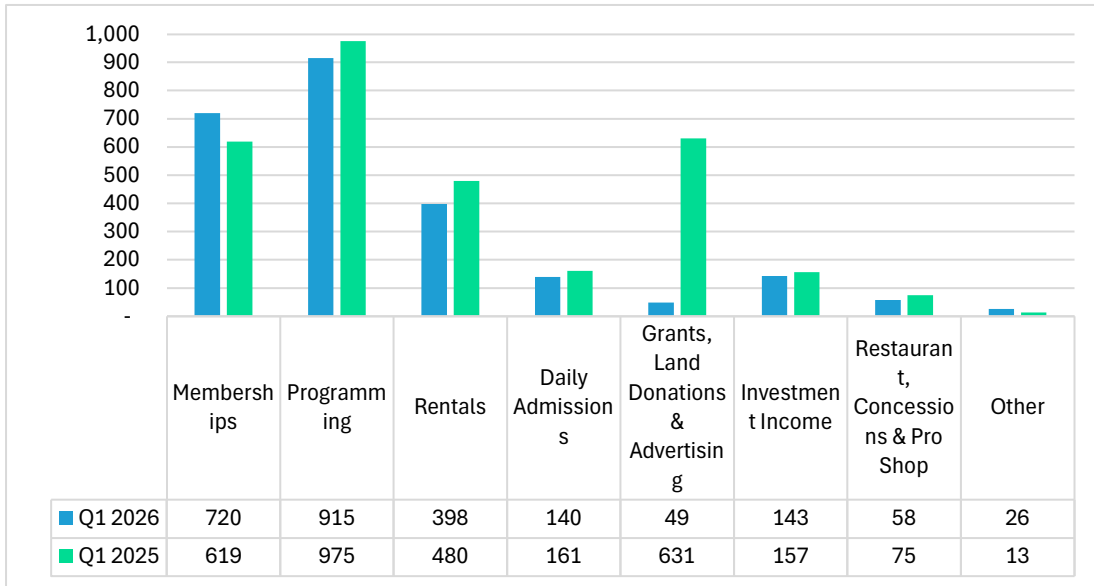

### **Motion:**

Recommend the April Administration & Finance Report be included in the April Executive Director's Report for Board approval.

### **Finance:**

- Auditors were on-site April 14-16, and communicated the audit has gone well, especially for a new audit.
- Completed and filed Illinois Department of Employment Security reports for 1Q2026. Going forward, all reports will be filed by Paycom.
- Developed quarterly balanced scorecard.

### **Technology:**

- A new camera was installed in the main gym at Willow Rec Center and the existing camera was upgraded to increase visibility of the entire gym including the exit doors.
- The Axis M1055 camera with night vision works well. The camera in the Triphahn Center's server room was replaced. We will be upgrading other cameras with the need for night vision using this model.
- The two existing cameras covering the gym at Triphahn Center were upgraded to improve visibility.
- IT installed a new security camera, an emergency wall phone, and the Comcast TV box to the newly installed 65" TV in the strength room.
- IT plans to install an emergency wall phone in the gymnastics studio and the cardio room as well.
- For the Comcast Fiber Upgrade, IT worked with SNI to prepare all routers, switches and firewalls at Triphahn Center and the Parks Maintenance building for the cut over of our fiber network. Comcast has scheduled the cut over for Triphahn Center on April 22 and Parks building on April 23. We anticipate minimal downtime as we move cabling from one hardware to another.
- IT installed a new TV and Reach player for the Reach TV system on the north side of Triphahn Center. Both the main lobby and north side reach players are now showing a daily schedule of events.
- IT has completed the setup of the new HR and IT work order ticketing system at our custom domain, [servicedesk.heparks.org](https://servicedesk.heparks.org), and presented the new portal at our recent FT staff meeting.
- The email address, [support@heparks.org](mailto:support@heparks.org) will no longer be available to create tickets. All staff have been notified to utilize the new portal to open tickets/requests.
- IT is wrapping up the initial KnowBe4 cybersecurity awareness training sent out to users, with 91% completion. Staff is preparing the next campaign of random phishing emails with remedial training if needed. IT also presented a recap along with examples of phishing emails at our recent full-time staff meeting.

## **Human Resources:**

### **Recruitment and Onboarding:**

- Human Resources onboarded 98 rehire packets through the Paycom system. Two in-person orientations were conducted for full-time employees, covering organizational policies, benefits, and workplace expectations. All full-time staff completed required Sexual Abuse Prevention and Cybersecurity Training on April 9, 2026.
- Staff continues to partner with Paycom representatives to streamline and consolidate data to ensure alignment with agency policies. Development of the HRIS platform remains ongoing, with a focus on improving hiring and onboarding efficiency for part-time and seasonal staff. During this reporting period, two Recreation Supervisors were successfully recruited and hired.

### **Risk Management:**

- With the onset of improved weather and increased park utilization, staff have been conducting inspections of playgrounds to ensure appropriate signage is in place and safety standards are maintained.

### **Benefits Administration:**

- To complete our transition to IPBC, Human Resources conducted a one-week open enrollment period for Voluntary Life Insurance through the PlanSource portal. Employees were provided the opportunity to confirm or modify coverage through April 17.

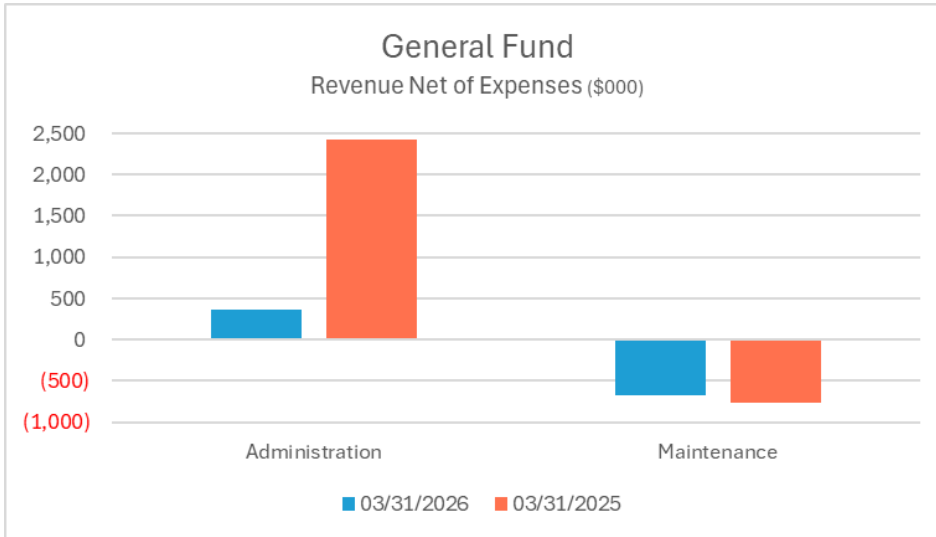

## Financial Analysis as of March 31st, 2026 Revenues Net of Expenses

### General Fund (01)



### Administration (01-10)

The Administration Department’s net revenue is \$2.2 million for Q1 below the prior year, due to the timing of tax receipts. In Q1 2025 we had begun collecting tax revenue and in Q1 2026 we have minimum tax revenue received.

Investment income variances are primarily due to differences in the timing and recognition of interest allocations between periods. In the prior year, investment income was recorded in the General Fund during the year, with a

fourth-quarter adjustment to allocate interest earnings across all funds. In the current year, interest is being allocated throughout the year as earned. As a result, the General Fund will reflect an unfavorable variance in interest income until the fourth quarter, while other funds will show favorable variances until the prior-year fourth-quarter adjustment is fully lapped.

### Maintenance (01-20)

The Maintenance Department’s net expense is \$95,000 lower in Q1 than the prior year. This decrease is primarily driven by reduced payroll related costs, as FICA and IMRF expenses are now allocated directly to their respective funds, and employee health insurance costs have been centralized in Fund 01 (Administration).

Repair and maintenance expenses for Bridges have increased. Some key expenditures include dumbwaiter repair and testing (\$12.7 thousand) and door repairs and replacements (\$10.4 thousand).

### Fund Summary

The General Fund's Q1 revenue net of expenses is \$2.1M less than the net revenue from the prior year, excluding capital spending.

## Recreation Fund (02)

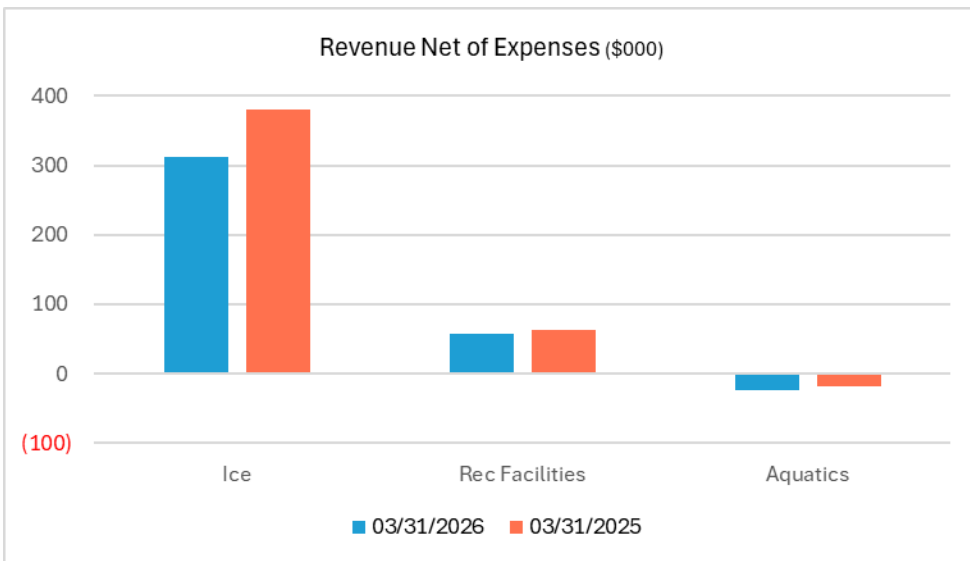
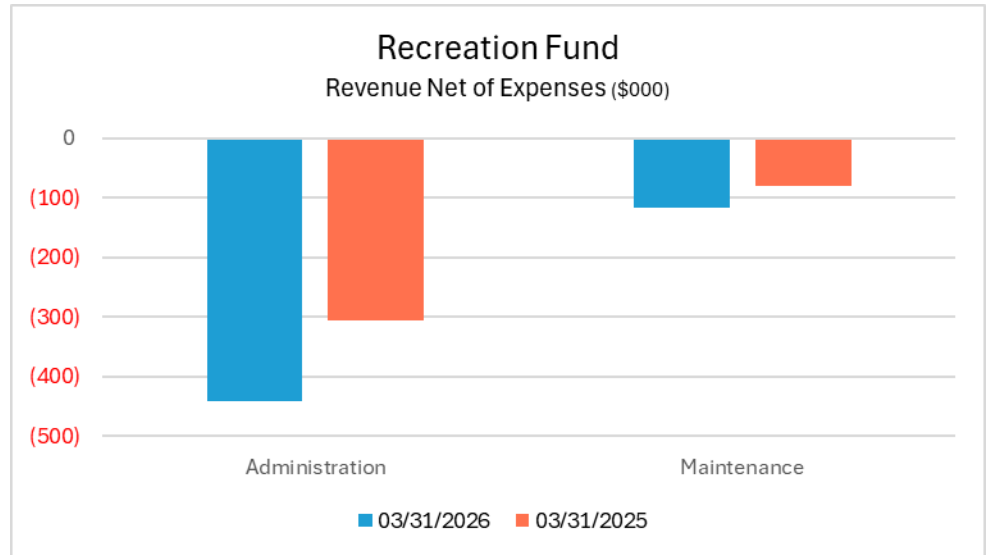
### Administration (02-10)

Net revenue for the Administration Department is \$135,000 in Q1 lower than the prior year.

This variance is driven by property tax revenue, which is \$210,000 lower than the same period last year. Payroll expenses were \$74,000 more favorable compared to the prior year due to budget reallocation.

### Maintenance (02-20)

Spending in the Maintenance division increased by almost \$38,000 compared to the prior year. This variance is due to budget reallocation of maintenance staff.



### Ice (02-85)

Revenue in the ICE division is \$68,000 lower in Q1 than the prior year. This variance is driven by a \$34,000 decrease in the premium locker room rentals with the Wolves departure and a \$20,000 decrease in ice rental revenue due to the decline in Timberwolves teams and ice rental compared to the same period last year.

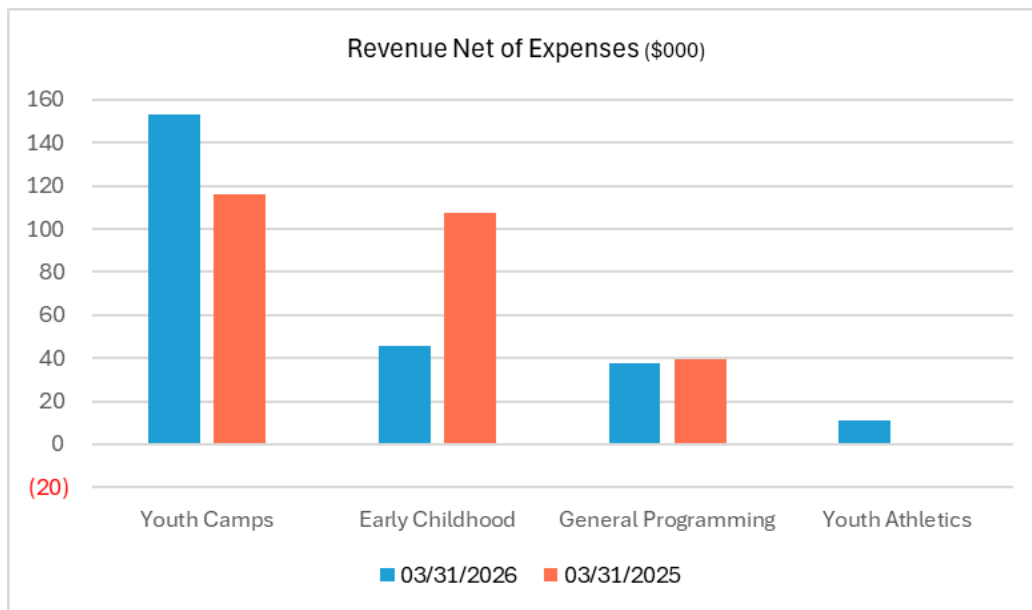
### Rec Facilities (02-32/34)

Budgeted payroll expenses increased (-\$12k) and increased spending on supplies and equipment (-\$10k) in Q1 were the primary drivers of the \$5.8k shortfall compared to the prior year in Recreation. The rise in payroll reflects staffing adjustments, while the increase in supplies and equipment is tied to elevated program demand and facility needs. These cost increases were partially offset by stronger revenue performance, including higher membership income (+\$10k) and increased facility rentals (+\$8.7k).

### Aquatics (02-80)

Uniform expenses were \$5,700 Q1 2026 compared Q1 2025, due to uniforms arriving Q1 in the current year versus Q2 in prior year.

## Recreation Fund (02) continued



### Youth Camps (02-65)

Net revenue increased by \$36,600 in Q1 compared to the prior year, driven by a \$20,600 increase in STAR District 54 programming with increased enrollment and a \$7,700 increase in STAR trip net revenue.

### Early Childhood (02-60)

Net revenue decreased by \$61.7k in Q1 compared to the prior year due to the elimination of the LSC program.

### General Programming (02-50)

Most program areas showed positive year-over-year improvement in Q1, led by Gymnastics (+\$7k) with the Willow Center renovation. Dance, Special Events, and General Programming areas also contributed, each increasing by approximately \$3.5k.

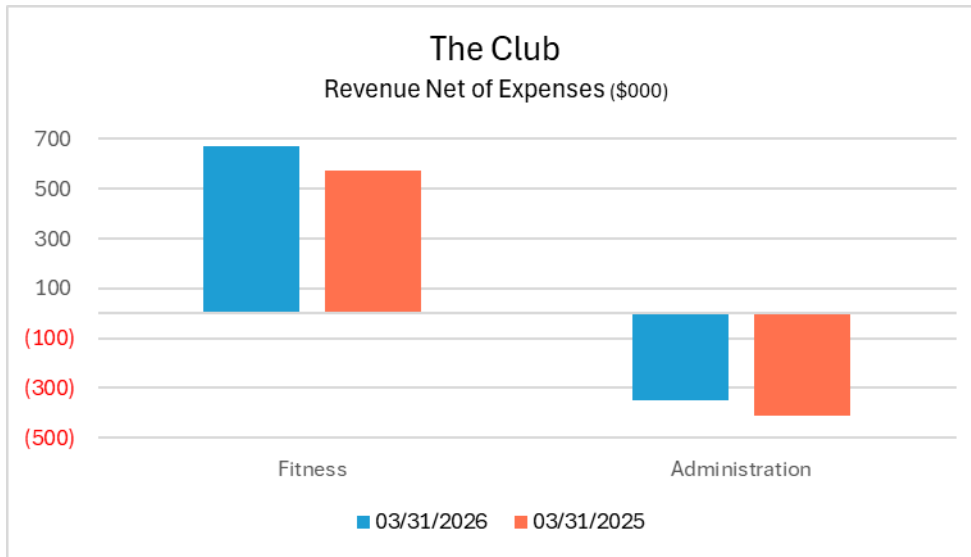
### Youth Athletics (02-75)

Youth Soccer was the primary driver of revenue growth in youth athletics, largely due to the addition of indoor classes, which expanded program capacity and seasonal offerings in Q1. Most other programs also contributed positively, posting modest increases that further supported overall revenue growth in the division.

### Fund Summary

The Recreation Fund's net revenue (excluding capital spending) is \$263,000 lower in Q1 than the prior year. The variance is largely related to the timing of program offerings and scheduling cycles, rather than indicative of any broader decline in overall operations.

## Club Fund (11)



### Fitness (11-30)

Fitness program net revenue increased by \$100,000 in Q1 compared to the prior year. This improvement is primarily driven by an increase in membership levels as well as higher monthly membership fees.

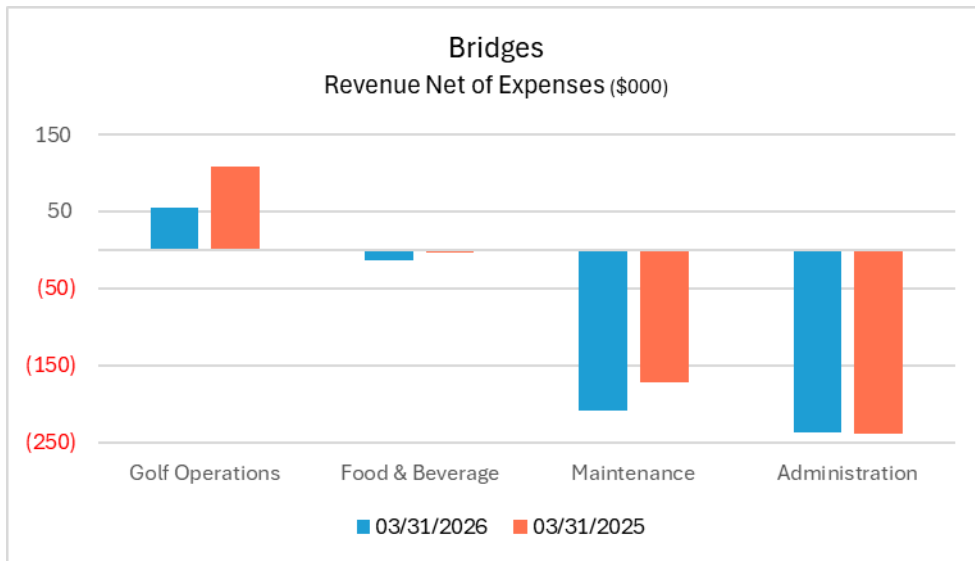
### Administration (11-10)

Administration costs decreased in Q1 by \$55,000 compared to the prior year.

### Fund Summary

Overall, revenues net of expenditures improved by approximately \$136,000 at The Club in Q1. This favorable variance is largely driven by strong performance in fitness operations and membership growth.

## Bridges Fund (14)



### Golf Operations (14-40)

Top Tracer rental fees were down \$42,000, while greens fees declined \$21,000 compared with the prior year. These variances were largely driven by an unusually cold winter, snowfall, and a later start to the season, with the golf course not opening until the end of March. As weather conditions improve and a full operating schedule begins, these categories are well positioned to recover and strengthen in the upcoming peak golf months.

### Food & Beverage (14-45)

Compared with Q1 2025, Q1 2026 showed weaker operating performance. Total revenue declined by \$20.4K, while expenses declined by \$10.1K, resulting in a net loss of \$(14.4K) versus \$(4.1K) last year. The decline was driven primarily by lower food and beverage sales tied to the challenging spring weather which affected golf operations.

### Maintenance (14-20)

Payroll costs were \$36.5K higher than the prior year, primarily due to the addition of the newly budgeted full-time Golf Course Superintendent position. This increase reflects a planned investment in staffing to support course conditions, operations, and service levels rather than an unplanned rise in payroll expense.

### Fund Summary

Overall, Bridges delivered a solid first-quarter performance despite a challenging start to the season driven by unusually cold weather, snowfall, and a delayed golf course opening until the end of March. While several revenue areas were impacted by the later start, the fund remains well positioned for improvement as peak operating months begin.
